- 4 MR. RIVERA: We are live in the room.
- 5 CHAIR NEJABAT: All right.
- 6 Good morning.
- 7 Today is Tuesday, October 14th, and the time is 9:33 a.m.
- 8 I now call this meeting of the 22nd District Agricultural
- 9 Association Board of Directors to order.
- 10 I want to start off by thanking Director Schenk for his
- 11 years of service and the presidency.
- 12 As I've quickly come to learn, it is a time-consuming
- 13 task.
- I know we're all appreciative of that and speaking for
- 15 everyone when I say that.
- 16 So thank you, Director Schenk.
- Moving on to roll call.
- Donna, may we please call the roll?
- 19 MS. O'LEARY: Chair Nejabat.
- 20 CHAIR NEJABAT: Here.
- MS. O'LEARY: Vice Chair Barkett.
- VICE CHAIR BARKETT: Here.
- MS. O'LEARY: Director Arabo.
- 24 DIRECTOR ARABO: Here.

- 1 MS. O'LEARY: Director Blair has an excused absence.
- 2 Director DeBerry.
- 3 DIRECTOR DeBERRY: Here.
- 4 MS. O'LEARY: Director Gelfand.
- 5 DIRECTOR GELFAND: Here.
- 6 MS. O'LEARY: Director Mead.
- 7 She's going to join us via Zoom.
- 8 Okay.
- 9 Director Rowland is unable to join us today.
- 10 And Director Schenk.
- 11 DIRECTOR SCHENK: Here.
- 12 CHAIR NEJABAT: Great, we have a quorum of board members
- 13 present in the room.
- 14 Moving on to closed executive session.
- 15 The Board will now move on to our closed executive
- 16 session to discuss matters described under item 3 on the
- 17 agenda.
- 18 We anticipate returning to open session around 10:30
- 19 a.m., about an hour.
- The current time is 9:34 a.m., and pursuant to the
- 21 authority of Government Code Section 11126(a), (b), and (e),
- 22 the Board of Directors will meet in closed executive sessions
- 23 on the items described on today's agenda.

- 3 [The Board has returned from closed executive session at

- 6 CHAIR NEJABAT: The time is 10:35 a.m.
- 7 We have returned from our closed executive session.
- 8 The 22nd DAA Board of Directors considered the advice of
- 9 counsel on the items listed on the closed session portion of
- 10 the agenda and has nothing to report.
- 11 With that, our first order of business is the consent
- 12 calendar.
- Do we have any members of the public in the room that
- 14 would like to speak on the consent calendar as presented in
- 15 the agenda?
- 16 Seeing none.
- 17 We have no public speakers on Zoom.
- 18 Are there any requests from the Board to remove any items
- 19 from the consent calendar for further individual discussion?
- 20 All right, seeing none, do I have a motion for approval
- 21 on the consent calendar.
- 22 DIRECTOR SCHENK: So moved.
- 23 CHAIR NEJABAT: Director Schenk for the motion.
- 24 Second?

- 1 Director DeBerry.
- Donna, may I have the roll?
- 3 MS. O'LEARY: Chair Nejabat.
- 4 CHAIR NEJABAT: Aye.
- 5 MS. O'LEARY: Vice Chair Barkett.
- 6 VICE CHAIR BARKETT: Aye.
- 7 MS. O'LEARY: Director Arabo.
- 8 DIRECTOR ARABO: Aye.
- 9 MS. O'LEARY: Director DeBerry.
- 10 DIRECTOR DeBERRY: Aye.
- MS. O'LEARY: Director Gelfand.
- 12 DIRECTOR GELFAND: Aye.
- MS. O'LEARY: Director Mead
- 14 DIRECTOR MEAD: Aye.
- MS. O'LEARY: Director Schenk.
- 16 DIRECTOR SCHENK: Aye.
- 17 CHAIR NEJABAT: All right.
- 18 The motion carries.
- 19 We'll now move on to public comment for items not on
- 20 today's agenda.
- 21 As a reminder, the Board will not debate nor act on any
- 22 comments heard today.
- If you are here to speak on an agenda item, please wait
- 24 until we take that item up.

- 1 For all public comment opportunities today each speaker
- 2 will be given two minutes to make their remarks.
- 3 Be prepared and ready to speak as soon as you are
- 4 recognized to do so.
- 5 Out of respect for everyone's time, we'll mute your
- 6 microphone a after two minutes.
- 7 Do we have any public speakers in the room today for
- 8 matters not on the agenda.
- 9 If so, please queue up at the podium.
- 10 AMY CHESHIRE: Honorable chair and members of the board,
- 11 my name is Amy Cheshire.
- 12 I'm here representing the Coalition for Safer Trains, a
- 13 group of community members who have been participating in the
- 14 public process to help develop a railroad alignment that
- 15 minimizes impacts to the community and is resilient to sea-
- 16 level rise.
- 17 Back in February in response to SANDAG's first NOP we
- 18 proposed a route now called the northern yellow line that has
- 19 been embraced by the community at large and is currently being
- 20 studied by SANDAG.
- 21 We read the comment letter the 22<sup>nd</sup> DAA submitted to the
- 22 SANDAG for the second NOP, and were taken aback why the
- 23 negative characterization of our efforts as member of the
- 24 public members of the public participating in the public

- 1 process to determine the LOSSAN rail relocation alignment.
- 2 This level of public participation is consistent with the
- 3 first guiding principle for your Master Site Planning process,
- 4 in which you emphasized broad community outreach and input is
- 5 foundational to the process.
- 6 We understand the northern yellow line route is a
- 7 relatively new concept and the timeline has been short for
- 8 everyone involved to study it thoroughly.
- 9 However, there is strong support in the community for
- 10 this proposal and potential advantages for the fairgrounds
- 11 that should be explored by this board.
- 12 We were glad to see the polling data presented at
- 13 September's Board meeting.
- 14 The top two priorities expressed by the residents of San
- 15 Diego County for the future of the fairgrounds are one,
- 16 access, parking, and public transit.
- 17 Two, preservation of the coastal character and
- 18 environment.
- 19 The northern yellow line is the rail alignment that best
- 20 achieves the priorities and everyone, including the
- 21 fairgrounds.
- 22 It should be thoughtfully considered as part of your site
- 23 planning process.
- We respectfully request a subcommittee of your board meet

- 1 with us in person to listen and learn more how our proposed
- 2 northern yellow line route could minimize impacts to
- 3 surrounding communities while also providing benefits to the
- 4 fairgrounds.
- 5 Thank you for considering our request and we look forward
- 6 to meeting with members of the board in the near future.
- 7 CHAIR NEJABAT: All right.
- 8 Perfect timing.
- 9 Thanks for your comments.
- 10 Anybody else?
- 11 CARLA ECHOLS-HAYES: Hello everyone.
- 12 I'm Carla Echols-Hayes, Friends of Del Mar Horsepark.
- I've seen you before.
- Is this not on?
- It's on, okay cool.
- Okay, so this weekend there is a Halloween dressage show
- 17 which is a lot of fun.
- I know everybody thinks dressage is like this really
- 19 boring thing but it really isn't.
- 20 You have dancing horses with costumes, now that's
- 21 actually pretty cool.
- They have a dog costume contest.
- There's a lot more diversity of events happening at
- 24 Horsepark.

- 1 The dog agility people are using the old grass field
- 2 which nobody else can use because it's not good for horses and
- 3 we've got a lot more public participation.
- 4 And I wanted to invite all of you if you have grandkids
- 5 who want to see dancing horses in costume.
- 6 It's pretty cool actually.
- 7 And for adults there is at 5:00, one of those charity
- 8 casino night things where you play for prizes but there's no
- 9 money involved.
- I wanted to tell all of you, hey, I know you probably
- 11 don't look at Instagram, if you probably don't looking at the
- 12 Facebook I post but you might listen at one of these meetings,
- 13 so I hope all of you can get there.
- 14 Thank you very much for supporting Horsepark, I
- 15 appreciate it.
- 16 CHAIR NEJABAT: Thank you for your comments.
- 17 It looks like that with we'll move on to the three
- 18 speakers on Zoom, starting with Jane Cartmill.
- 19 JANE CARTMILL: This is a report with some parallel I
- 20 believe this board could learn from.
- It was published on October 6th by NBC in South Florida.
- 22 Quote, a new chapter is beginning for the Miami Sea
- 23 Aquarium as a developer filed for bankruptcy court approval,
- 24 takeover the troubled marine park's lease.

- 1 It's the final weeks of the Miami Sea Aquarium as we've
- 2 known it for decades.
- 3 In just one week the park will close its doors and its
- 4 beloved marine mammals will retire, marking the end of an era
- 5 and the beginning of a new chapter.
- 6 We're going to be preserving the Golden Dome and we're
- 7 going to have a celebration for marine life with immersive
- 8 experiences but no marine mammals.
- 9 But I think it's going to be an amazing, friendly
- 10 destination for this community, David Martin, the developer
- 11 said.
- 12 The project will also prioritize working with local
- 13 partners on education and conservation efforts related to
- 14 Biscayne Bay.
- 15 We have universities like the University of Miami that is
- 16 adjacent that we really look for a potential strong
- 17 partnership with, Martin said.
- 18 As for the marine mammals, they will be relocated with
- 19 oversight from the bankruptcy trustee and the county to ensure
- 20 their welfare.
- 21 Thank you.
- 22 CHAIR NEJABAT: Thank you.
- Next up, we have Martha Sullivan.
- 24 MARTHA SULLIVAN: Hello, this is Martha Sullivan from

- 1 Imperial Beach.
- 2 This report was published on October 8th just before
- 3 Indigenous People's Day yesterday.
- 4 And it is significant for tribal gaming everywhere,
- 5 particularly here in California, which generates roughly a
- 6 third of \$42 billion nationwide tribal gaming gross revenue.
- 7 Quote, the U.S.
- 8 Supreme Court has ruled in favor of Washington's
- 9 established tribal gaming laws and regulations remaining in
- 10 place despite a challenge made by RunItOneTime, formally
- 11 Maverick Gaming.
- 12 The Indian Gaming Regulatory Act is a core piece of
- 13 tribal law that was enacted by Congress in 1988.
- 14 This led to the formation of the National Indian Gaming
- 15 Commission, which regulates any gambling activity on tribal
- 16 lands throughout the United States.
- 17 Maverick Gaming, which then became RunItOneTime
- 18 challenged the IDRA and Shorewater Bay's rights as well as all
- 19 tribal gaming in Washington state.
- The Supreme Court has once again rejected a meritless
- 21 suit that sought to attack the very heart of tribal rights.
- 22 At the Native American Rights Fund, we stand ready to
- 23 defend against these attacks wherever they are filed, said
- 24 NARF's staff attorney, Lenny Powell.

- 1 Thank you.
- 2 CHAIR NEJABAT: Thank you.
- 3 It doesn't look like we have anybody else so with that,
- 4 we'll move on to item number 7 on our agenda today.
- 5 At this time I would like to recognize our CEO Carlene
- 6 Moore to provide her executive report.
- 7 MS. MOORE: Thank you.
- 8 So first up regarding the Fairgrounds 2050 update as you
- 9 recall last month we had an update by our on our overall
- 10 approach and strategic communications approach to this, our
- 11 Master Site Planning outreach efforts that included polling
- 12 results, the outreach and planned open houses on the horizon.
- 13 And these are additional community outreach events.
- I wanted to provide a brief update on things since last
- 15 month.
- 16 Since our last meeting we have also briefed and presented
- 17 at the Solana Beach City Council as well as did a briefing
- 18 with San Diego City Council president Joe LaCava, in terms of
- 19 the process.
- I wanted to share with you that he was very complimentary
- 21 of, what he said was, and I quote, our strategic and
- 22 deliberative approach to our Master Site Plan.
- 23 For the record, he told us it was unlikely we would have
- 24 a venue to be able to present this at the San Diego City

- 1 Council.
- 2 They operate differently than most other councils, so
- 3 we're looking at other means of updating those councilmembers.
- 4 We also were scheduled to present to Del Mar City
- 5 Council, but they unfortunately had to cancel their most
- 6 recent meeting, so we've been rescheduled for the presentation
- 7 on October 20th.
- 8 In terms of our open houses we've had the first of two
- 9 held earlier this month, Poway on October 1st and La Mesa on
- 10 October 6<sup>th</sup>.
- 11 And overall been happy with how they turned out, the
- 12 process that we arranged for it, the opportunity, again, to go
- 13 out into our community and hear from our community members.
- 14 We've done a lot of marketing around that, eblasts,
- 15 social media ads and so forth to help spread the word.
- 16 But we could always use your help as well and other
- 17 members in our community to further that.
- 18 We have more on the horizon.
- 19 Our team has been there at those events and working with
- 20 Southwest Strategies and enjoyed that opportunity to engage as
- 21 well as for those board members, and I want to thank you, that
- 22 have been able to attend so far.
- 23 And that has included Director Barkett, Director Nejabat,
- 24 Director DeBerry, Director Rowland as well, Director Gelfand.

- 1 So thank you very much.
- 2 Hopefully, we'll see the rest of you at our upcoming.
- 3 We have four more events still planned, the next one is
- 4 next Monday, October 20th.
- 5 That one will be in Central San Diego.
- 6 October 29th we will be in San Marcos.
- 7 November 13<sup>th</sup> we'll be in Chula Vista.
- 8 And our final one, November 18<sup>th</sup>, which is the same day as
- 9 our board meeting, but in the evening here at The Sound, and
- 10 we really do expect this to be our largest event as we get
- 11 closer to home.
- 12 Looking ahead, we will be working on various aspects of
- 13 the plan with the committee assignments that Chair Nejabat has
- 14 appointed.
- 15 And so then we should have another quarterly update at
- 16 the November board meeting because, again, that just quarterly
- 17 cadence of those updates.
- 18 Moving on to the progress report on affordable housing
- 19 discussions with the City of Del Mar.
- 20 So this is I know we have an item later on regarding the
- 21 exclusive negotiating rights agreement, but this really is an
- 22 update.
- I'm sorry, did you have a question?
- 24 >> [off mic]

- 1 MS. MOORE: Yes.
- DIRECTOR GELFAND: November [off mic]
- 3 MR. RIVERA: Microphone please.
- 4 DIRECTOR GELFAND: At the November meeting will we get an
- 5 update on what happened on the public outreach meetings that
- 6 have occurred at least to date?
- 7 I know there will be a couple of more in November, the
- 8 night of the meeting and afterwards, but will we get some
- 9 interim data or will that come at the end?
- MS. MOORE: I think we can look at that and maybe some
- 11 high-level themes that we're hearing, but otherwise to bring
- 12 that information back collectively.
- So in terms of then moving onto again just kind of the
- 14 progress report.
- This is the request to have a monthly updates.
- So as everyone is aware, we do have the exclusive
- 17 negotiating rights agreement with the City of Del Mar we
- 18 entered into to explore whether to cite affordable housing
- 19 here on a portion of the District's property.
- 20 And I think one thing that is really important to remind
- 21 everyone of us in terms of those discussions, we collectively
- 22 have said as the District Agricultural Association is if
- 23 affordable housing is going to be cited we wanted to be cited
- 24 in the place most appropriate to our activities, how the

- 1 public engages with our property.
- 2 And then there's the request of the City of Del Mar,
- 3 which for them currently to receive RHNA credits means it
- 4 being in essence with their boundaries.
- 5 And we have a unique situation as the District because we
- 6 are in two cities.
- 7 Even as close as this property is, it's literally Jimmy
- 8 Durante that divides that line.
- 9 And I share that with you as a reminder because, so the
- 10 due diligence work has been well underway.
- 11 And our team primarily lead by our supervising
- 12 environmental planner, Dustin Fuller, continue to meet with
- 13 the city as well as our consultants regularly.
- 14 The work has included the feasibility studies that are
- 15 being conducted.
- 16 And this is utilizing the California Department of
- 17 Housing and Community Development or HCD as it's called and
- 18 those housing acceleration program funds.
- 19 This was grant funds commonly referred to as the HAP
- 20 funds to facilitate potential site selection.
- 21 And that's what's key here as well is potential.
- 22 And so these funds were made available to us and that's
- 23 where we executed the Memorandum of Understanding with the
- 24 City of Del Mar to be able to have access to those funds to

- 1 that grant opportunity.
- 2 And that came to us through the opportunity through the
- 3 ENRA, as it's called.
- 4 The M.O.U. so it funds the task orders that are
- 5 associated with the HAP grant, and that is the mechanism for
- 6 us to get reimbursed on those expenses.
- 7 And that is included sort of affordable housing
- 8 consultant services, identify CEQA constraints,
- 9 transportation, due diligence that needs to be done there,
- 10 sea-level rise vulnerability as well as water and sewer master
- 11 planning.
- 12 These studies are currently in progress.
- 13 A thing to note is that in addition to while it's being
- 14 pursued with regard to this consideration for affordable
- 15 housing -
- I just want to check, so did we lose Zoom or just the TV?
- Okay, just to make sure so I can keep going.
- 18 Okay.
- 19 Oh, okay.
- In front of us it went black just so the audience out
- 21 here knows as well.
- These studies are beneficial to our Master Site Plan,
- 23 regardless of affordable housing and there's still that to be
- 24 determined.

- 1 This due diligence that we're doing, this information
- 2 will be beneficial to our Master Site Plan.
- 3 And then separately we can have that determination of
- 4 affordable housing.
- 5 >> [off mic]
- 6 MS. MOORE: We have a consultant that we work with and
- 7 then our staff and Supervising Environmental Planner is our
- 8 key staff person on that.
- 9 >> [off mic]
- MS. MOORE: That is directed by the DAA.
- 11 What we have to work with and that is what the M.O.U.
- 12 outlines is we have to seek approval under the grant funds
- 13 like you do with any grant for these are the considerations,
- 14 here's what needs to be studied.
- 15 City of Del Mar has identified those as well because they
- 16 need that information as they look at affordable housing here
- 17 at the fairgrounds.
- And so it's mutually agreed upon in terms of the
- 19 activities that need to be done through this due diligence
- 20 process as required for housing.
- 21 >> [off mic]
- MS. MOORE: Yes.
- So, and that's one of the things.
- 24 So then the ENRA, the Exclusive Negotiating Rights

- 1 Agreement, what it does is it outlines and that's where there
- 2 is key milestone dates and that's from an update perspective.
- 3 For you as board members that's when we would truly have
- 4 information to share with you at that time, including the
- 5 results of the studies.
- 6 Because that's going to inform our Master Site Plan.
- 7 And then it will also be utilized to inform again as this
- 8 board looks ahead to the future for making a determination
- 9 about affordable housing.
- 10 VICE CHAIR BARKET: Carlene, could we get Dustin Fuller to
- 11 give us an overview of where they are at with the different
- 12 ones that are currently being done under the HAP.
- 13 MS. MOORE: Yes, so Dustin will come and make the
- 14 presentation when we have that information.
- 15 Right now what we have is a question for you.
- 16 Kind of for this board.
- 17 And that is going back to what we said about and this
- 18 board has if affordable housing is cited here, we want it to
- 19 be in to kind of occur in the best place for the residents of
- 20 it, for our activities, you know, recognizing traffic and
- 21 things like that.
- 22 We have an interesting -- we're in an interesting
- 23 position as the District in having this request because there
- 24 is our land mass that is in the City of Del Mar's boundaries

- 1 and then there is our land that is in the City of San Diego.
- 2 There are two studies that if we want to explore all
- 3 potential options there are two studies that would not be
- 4 funded through the HAP grant that would be necessary to
- 5 potential sites outside of the City of Del Mar's boundaries.
- 6 It's about \$30,000 in expense for those.
- 7 It's related to the water and sewer studies that need to
- 8 be done.
- 9 But if we want that as an option, as the District to
- 10 consider, that's an expense that we would need to incur
- 11 outside of the reimbursable HAP grant funds.
- 12 VICE CHAIR BARKETT: Okay.
- I also know there's a study that was done in 2018, a very
- 14 comprehensive one with the City of Del Mar.
- 15 And it was made public.
- 16 Do we have that in our records?
- 17 Because we should, that study.
- MS. MOORE: Yeah, I'm sure that if there was a study that
- 19 was done in 2018, I'm sure that we have that in our records.
- 20 And I will see about having that be brought forward at
- 21 our next meeting.
- VICE CHAIR BARKETT: Or at a future meeting?
- MS. MOORE: Mm-hmm.
- 24 VICE CHAIR BARKETT: Okay.

- 1 Thank you very much.
- MS. MOORE: Yes, thank you for that.
- 3 >> [Off mic]
- 4 MR. RIVERA: Microphone please.
- 5 DIRECTOR GELFAND: In the board packet in the description
- 6 of new committees and their structure and whey they're
- 7 supposed to, you know, deal with.
- 8 I don't see this issue of Del Mar and the ENRA and the
- 9 housing issue that Del Mar affordable housing issue.
- 10 Would it fall under the Regulatory and Government Affairs
- 11 Committee purview or maybe that's a Sam question.
- 12 MS. MOORE: Yeah, I don't know that that's a question that
- 13 I could answer at this time.
- 14 But the approach that we have had is bringing this
- 15 information at this time, bringing this information back to
- 16 the full board.
- 17 And so that might be something for consideration in terms
- 18 of committees.
- 19 DIRECTOR GELFAND: It seems like there ought to be some
- 20 committee of the board that is dealing with this issue.
- 21 And so I mean maybe it's up to you, Sam, to figure out
- 22 which committee that is or if maybe it's an ad hoc committee.
- It hasn't been formed yet.
- 24 Maybe it falls under government affairs.

- 1 But we ought to get on it.
- 2 DIRECTOR DeBERRY: Is that a recommendation?
- 3 MS. MOORE: Well, it's definitely something that, yeah, it
- 4 can be taken into consideration.
- 5 This is my executive report, it's not an action item in
- 6 terms of anything so our counsel isn't getting too nervous
- 7 over there.
- 8 DIRECTOR GELFAND: Well, we have a weird -
- 9 MS. MOORE: So your feedback is being received.
- 10 DIRECTOR GELFAND: Yeah, we have a weird structure because
- 11 action items have to be noticed in advance.
- 12 And there is no clear mechanism for how to get something
- 13 on the agenda in advance unless you happen to be the chair.
- 14 MS. MOORE: You as board members can reach out to the
- 15 chair if you would like an item to be place on the agenda.
- 16 DIRECTOR GELFAND: Consider yourself reached out to.
- 17 DIRECTOR SCHENK: But the issue though is you know Bagley-
- 18 Keen.
- 19 And that's why it's always a sensitive circle that one
- 20 has to go through or route one has to go through for that.
- 21 So yeah, really best to direct your inquiry to Carlene
- 22 and then Carlene with the chair can make a decision as to
- 23 which committee it will be assigned, to which committee.
- 24 So that you don't get conversations one after the other.

- 1 DIRECTOR GELFAND: But the issue is, part of the issue is
- 2 it could just be assigned by the chair or it just could be
- 3 dropped by the chair.
- 4 And if the board wanted to actually force the issue and
- 5 say there should be a committee there is no real mechanism to
- 6 do that that I know of.
- 7 MS. MOORE: Well, this is the other arena, which is in the
- 8 course of this such as like what you have done here where
- 9 you're saying here in this meeting I'd like to see something
- 10 like this for consideration in the future.
- 11 And we have historically had that as well.
- DIRECTOR SCHENK: Right, because it's an open meeting.
- DIRECTOR GELFAND: But it can still be dropped by the
- 14 chair without a vote of the board.
- 15 DIRECTOR ARABO: Yeah.
- I've had that happen to me last year.
- 17 DIRECTOR SCHENK: Not by me.
- 18 It's not dropped.
- 19 It has never been dropped.
- It just hasn't been assigned out to committee.
- 21 DIRECTOR ARABO: I'm not directing it towards you.
- It was towards the committee, it wasn't to the former
- 23 President Schenk.
- MS. MOORE: Okay, with that I'm going to move on.

- 1 That's kind of an update on where we're at with regard to
- 2 those studies and those the use of those HAP grant funds.
- I also wanted to share with you, as you consider item 8F
- 4 on the agenda.
- 5 Because we do have contracts with consultants through in
- 6 essence this funding mechanism of the HAP grant.
- 7 So any consideration of the amendments the ENRA just need
- 8 to take into consideration the impact that might have to that
- 9 funding mechanism for that work.
- 10 We are it's anticipated that through this, what we are
- 11 receiving again beneficial to our Master Site Plan is about
- 12 three quarters of a million dollars, around \$750,000 of work
- 13 valuable to our Master Site Planning process.
- Just very briefly in terms of construction projects and
- 15 facilities updates, we have received the facility condition
- 16 assessment report.
- 17 And our Chief Administrative Officer, Mike Seyle and our
- 18 Facilities Director, Brad Mason have been working through it,
- 19 pulling through it as we prepare an executive summary of the
- 20 approximately 800 page document.
- 21 So it's very robust in that.
- 22 Additionally, we are working with the Del Mar
- 23 Thoroughbred Club to strategize a multiyear approach to the
- 24 capital expenditures plan, the needs of the facility, but also

- 1 some of the projects both of either of us would like to see
- 2 accomplished over the next few years.
- 3 And so at the Finance Committee's recommendation, we're
- 4 going to present on that at next month's meeting as we also
- 5 present our capital expenditures budget and our operating plan
- 6 and budget for the coming year.
- 7 So more to come on that.
- 8 Industry news and updates.
- 9 I'm really excited to share with you that just yesterday
- 10 we received word that Governor Newsom signed AB258 into law.
- 11 So I just want to take a moment to thank all of you, any
- 12 one of you who may have reached out on not only our behalf,
- 13 but on behalf of the industry to help bring that to a reality.
- 14 As you'll recall, I serve on the California Affairs
- 15 Alliance Board of Directors, which is the organization that
- 16 brought this bill forward.
- 17 It's really something we have been working on for three
- 18 years and so to finally now have it.
- 19 And what this bill will do is significantly increase, in
- 20 essence, the funds that the industry is receiving, and for
- 21 that, the 74 fair organizations in it.
- 22 Because what it does is changes the state's funding
- 23 calculator.

- 1 So previously, since 2017, the industry has been
- 2 receiving three quarters of 1% of the total gross sales
- 3 generated on California fairgrounds.
- And under AB258, that has now been increased to 2% of the
- 5 total sales generated on the fairgrounds.
- 6 So again, significant and a major milestone.
- 7 And we're very appreciative of Governor Newsom, and like
- 8 I said, and then just all of the grassroots efforts to get
- 9 this one signed into law.
- 10 So and with that, that concludes my executive report.
- 11 CHAIR NEJABAT: All right.
- 12 Thank you.
- 13 Any other questions from the Board?
- 14 No.
- Do I have anyone from the public that wishes to speak on
- 16 this item?
- 17 Executive report?
- 18 No?
- 19 All right.
- 20 That concludes our public comment on the executive
- 21 report.
- With that, we're moving onto general business, which
- 23 consists of the items listed under section 8 of our agenda.

24

- 1 As a reminder, under Robert's Rules on action items our
- 2 procedure is as follows.
- 3 The item is read into the record.
- 4 Next we will entertain public comment, then we go
- 5 directly to a motion and second.
- 6 Then only after we have a motion and second do we open up
- 7 questions and discussion for the board.
- 8 And finally, we have a vote.
- 9 If we have no motion and second to begin discussions, we
- 10 will simply move on to the next item.
- 11 For information items, our procedure is as follows.
- 12 The item is read into the record.
- Next we have information presented.
- 14 Then we open for questions and discussion of the board.
- 15 Finally, we will entertain public comment.
- 16 The first item in our general business is item 8A,
- 17 Finance Committee Report.
- 18 This is an information item only.
- 19 And you can find the report beginning on page 13 of your
- 20 board packet.
- 21 Do we have any questions from the board?
- 22 No?
- 23 We'll now take public comment on the Finance Committee
- 24 report.

- 1 If you are in the room, please queue up at the podium.
- 2 All right, seeing nobody on Zoom as well.
- 3 We will now move onto item 8B, which is Fair Operations
- 4 Committee Report.
- 5 This is an informational item.
- 6 As you will recall, we carried over the presentation from
- 7 last month in the interest of time.
- 8 So I would like to now hand it over to Fair Operations
- 9 Committee chair, the 2025 San Diego County Fair, Director
- 10 Schenk to introduce this presentation.
- 11 DIRECTOR SCHENK: Thank you, Mr. Chair.
- 12 Well, we all know that the fair is critical to the
- 13 financial success of the District and it's vital to offer a
- 14 safe, fun, and engaging event for the members of our community
- 15 every summer.
- 16 And there are a lot of summer seasonal options throughout
- 17 San Diego County, and a lot of ways to enjoy the summer in San
- 18 Diego.
- 19 But the fair is unique and special and it's something
- 20 that we just don't find anywhere else.
- In fact, it is a I think about an eight-decade long
- 22 legacy that we have.
- 23 And I want to say I'm proud of our team that presents the
- 24 annual summer fair.

- 1 I'm proud of our board for the roles we play.
- 2 I'm grateful for all of our partners, our sponsors, all
- 3 the participants, the small businesses who make our fair work,
- 4 and especially the food vendors who set up shop along the
- 5 midway.
- 6 I'm always grateful to our community who keeps coming
- 7 back to spend summer with us.
- 8 During the summer I often walk with my credentials worn
- 9 along the midway.
- 10 I'll greet people, engage with them, try to answer their
- 11 questions.
- 12 And I get to see the smiles, the joy, the diversity that
- 13 makes up our San Diego County and the folks that come up out
- 14 to enjoy the fair.
- 15 So with tremendous gratitude, I get to now turn it over
- 16 to our CEO, Carlene Moore.
- 17 So that she can introduce the wrap-up for the 2025 San
- 18 Diego County Fair.
- 19 Carlene.
- 20 MS. MOORE: Thank you very much, Director Schenk.
- 21 And so as Katie makes her way up to the podium, our Chief
- 22 Operations Officer, to present on, I think she'll be joined in
- 23 moments by Tristan Hallman our Communications Officer as well.
- We have delayed this from last month's meeting.

- 1 And so but it's still timely and it's always nice to take
- 2 that moment to remember the joy, right, the joy we bring to so
- 3 many people in this community through the fair and the
- 4 activities that take place.
- 5 And this year, you know, the 2025 San Diego County Fair
- 6 was also we were at an interesting time in terms of in our
- 7 community and in our society as well.
- 8 And I am just so proud of our team for in essence the
- 9 product that we put forward to our community, the program of
- 10 it.
- 11 It was wonderful to experience, to see and on our take
- 12 aways, truly one of the best San Diego County fairs yet.
- 13 Very excited of what is to come.
- 14 But just to take us kind of through a brief walk down
- 15 memory lane of not see long ago, here is Katie to present on
- 16 the 2025 San Diego County Fair.
- 17 KATIE MUELLER: Thank you.
- 18 Good morning board members, public.
- 19 I'm really excited to be able to standup here and talk
- 20 about the 2025 San Diego County Fair but I have to acknowledge
- 21 I get to talk about it but it is huge, huge team effort, not
- 22 just form our own employees, but our partners, vendors,
- 23 contractors, sponsors, everybody.
- 24 So this year was a Summer Pet-tacular.

- 1 We all remember.
- 2 It seems like so long ago so forgive me if I say last
- 3 year, what I really mean is last season.
- 4 So take you on a little trip down memory lane.
- Just to remind everyone, the San Diego County Fair we're
- 6 self-sustaining.
- 7 It's our biggest annual event and largest gross and net
- 8 generator.
- 9 Two-thirds of the revenue that it takes to operate the
- 10 fairgrounds comes from the fair.
- 11 Which allows us to contribute to our environmental
- 12 investments that we make each year, our capital investments
- 13 and the property and our other year-round operations.
- 14 A recent study showed, so this is a recent number, that
- 15 we generate \$328 million in economic impact just in those 20
- 16 days.
- 17 You all remember this day, right?
- 18 Here we are all smiling.
- 19 We're all fresh faced, ready to take on the world, first
- 20 opening day.
- 21 So some numbers.
- 22 So if you look at our attendance speaker and sorry it's
- 23 kind of blocked there by the panel on the side.
- 24 But our overall attendance was relatively flat compared

- 1 to last year.
- 2 That, to me, was a win and I'll tell you why in just a
- 3 moment.
- 4 Our paid attendance was a bit down.
- 5 Our grandstand attendance was up.
- 6 We had more grandstand shows this year than previous
- 7 years.
- 8 So that downturn in paid attendance can mostly be
- 9 attributed to the state of our country and nation as Carlene
- 10 mentioned.
- 11 There was an incident, if you all recall back in May,
- 12 that happened right here in San Diego.
- 13 And frankly, it was an attendance impact on some
- 14 demographics that attend our fair regularly that we really
- 15 rely on to attend the fair and who are frankly some of our
- 16 biggest fans.
- We don't measure demographics of those who come through
- 18 our gates.
- 19 But as you can see, the impact to our Hispanic concert
- 20 series, we booked four Hispanic concerts, three of which has
- 21 been sell outs in the past.
- 22 You can see the first two weeks, Los Tigres Del Norte,
- 23 which was also a sell out at the Houston Livestock Show, one
- 24 of the largest fairs in the country.

- 1 And Banda MS, they were about half of the attendance that
- 2 we had anticipated.
- 3 So we worked really hard thanks to Tristan and the
- 4 marketing team to get the message out that the fair is a safe,
- 5 inclusive place.
- 6 And we worked hard on that message throughout the fair.
- 7 And our attendance did pick up at the shows as we got
- 8 later into the fair.
- 9 Still not beating, you know, last year, we had Los
- 10 Tucanes, which was a sell out and that attendance was down
- 11 just a bit too.
- The theme.
- 13 This was such a fun theme.
- 14 This is one of the most memorable themes that I've been a
- 15 part of in a while.
- And we've had a lot of really great themes at the fair.
- 17 We were celebrating the bond between humans and their
- 18 pets.
- 19 We had the Theme Exhibit.
- We partnered with the Humane Society, which was a really
- 21 wonderful partnership.
- 22 It gave us a platform to talk about a lot out things and
- 23 get a lot of media coverage.
- We partnered with Kahoots.

- 1 We had a Pet Pavilion.
- We did Puppy Yoga.
- 3 We had a Pet Fun Run.
- 4 We did a lot of pet-related entertainment, which was
- 5 hugely popular.
- 6 But the trick with celebrating pets while letting people
- 7 know they couldn't actually bring their pets.
- 8 And so we were a little nervous at the beginning about
- 9 having a lot of dogs and cats and things on leashes lined up
- 10 at the gate.
- 11 We got the message out early and really strong that this
- 12 was a celebration of pets and not a place to bring your pet.
- However, we did provide an opportunity for people to
- 14 bring their pets, the Pet-tacular pooch fun run happened the
- 15 last Saturday of the fair before the fair opened.
- 16 And it actually was a 5K that you could bring your dog or
- 17 cat, mostly they were dogs, to walk through the fair, do some
- 18 fun selfies in front of the Ferris wheel and other key stand
- 19 out places.
- 20 But at the end, it culminated into a festival where we
- 21 had pet costume contest.
- 22 We had a veterinarian on site to answer questions and
- 23 talk about pet nutrition.
- We had a D.J., it was really a lot of fun.

- 1 It turned out to be a great success.
- 2 And as I mentioned, pet-centric entertainment was a huge
- 3 hit and something that I think you will see at the 2026 fair
- 4 that we'll continue doing.
- If you saw those wiener dog and corgi races, oh, my gosh,
- 6 you could have a perfect vantage point from our new speakeasy
- 7 in the arena.
- 8 And that thing was packed all day long.
- 9 So that was a great hit.
- 10 Some other new things, Farm 2U.
- 11 We had a new exhibit about agriculture in O'Brien Hall,
- 12 which I'll talk about in a minute.
- 13 Rady's Children's Hospital event, which we'll talk about
- 14 in more depth.
- We had a brand-new San Diego Marketplace & Vendors, which
- 16 we were able to incorporate those who have handmade items that
- 17 maybe can't staff a booth for 20 days of the fair but they
- 18 could still have a presence at the fair.
- 19 We had lots of new food stands and foot items.
- We've really become like a foodie fair, which has been
- 21 great to see.
- We had a new KPOP festival, which adds to our repertoire
- 23 of diverse events that we have for our diverse audience going
- 24 on at the fair.

- 1 And then we had some new promotions.
- 2 Foodie Friday and Everyday Value Meals.
- 3 We brought back ticket sales at Albertsons and Vons,
- 4 which had a huge uptick which I'll talk about.
- 5 The season pass is back.
- 6 Came back for the first time since 2019, encouraging
- 7 people to come multiple days.
- 8 We added water refill stations and we made some great
- 9 layout changes that worked really well for the fair and moving
- 10 people around.
- 11 This is just some pictures of our new San Diego
- 12 Marketplace, which featured handmade items from local vendors,
- 13 extremely popular.
- 14 And then one of our goals to make the fair affordable, is
- 15 to make the fair affordable and accessible to all.
- And we work hard to provide a lot of opportunities to do
- 17 that.
- I don't know if everyone is aware of all of them because
- 19 there is so many.
- I always say if you are paying full price to come to the
- 21 fair you are not trying hard enough.
- 22 And as a reminder, the promotions that we present are
- 23 really only possible because of our vendors and our
- 24 relationships with our vendors, our concessionaires, our

- 1 carnival partners that allow us to collaborate and make these
- promotions really a win/win for everybody.
- 3 So we offered Game On Friday.
- 4 First time we've ever offered a game promotion on Fridays
- 5 to encourage daytime attendance.
- 6 You could play any game you wanted in the midway for four
- 7 tickets.
- 8 Normal prices are around eight tickets for a play.
- 9 We had Foodie Friday.
- 10 So winners of our Fair-Tastic Food Competition were half
- 11 price on Fridays to give people an opportunity to try those.
- 12 We had Everyday Value Melas.
- We had about over 20 vendors who offered a \$15 drink,
- 14 side, and entree to help people save money at the food
- 15 concessions.
- We sold 1,100 season passes.
- 17 As I mentioned, our Albertsons/Vons tickets were way up
- 18 from the codes that we used to distribute in 2024.
- 19 And then we sold quite a few tickets on our military
- 20 bases as well.
- 21 And then our returning deals we have kids days on
- 22 Fridays.
- 23 We have Costco packs, which are a great savings for
- 24 families.

- 1 O'Reilly Auto Parts sells tickets for us.
- We have our Pay-One-Price Wristband days, which have
- 3 become the biggest days at the fair, even bigger than some of
- 4 our weekends.
- 5 Horsepark and Canyon Crest were also available for
- 6 discounted parking.
- 7 And then there is no better value for your entertainment
- 8 dollar.
- 9 I mean, we've got a lot of competition in San Diego for
- 10 entertainment between all the amusement parks and the concert
- 11 venues and that kind of thing.
- But we had 1,200 hours of entertainment and over 18,000
- 13 entertainers that are included with your admission.
- 14 And then at the heart of the fair is the community.
- I think it's the community that really separates this
- 16 event from any other event that you can go to in the county.
- So we've got lots of programs for the community.
- 18 We've got our Fair-For-All.
- 19 You know of course, we host a Plant\*Grow\*Eat an ag
- 20 education event prior to the fair.
- 21 That's free to school kids.
- 22 We have a nonprofit and government associations that
- 23 participate at the fair.
- We do flag raising for Boy and Girl Scouts.

- 1 And we fill up faster than we can accommodate all the
- 2 Scouts.
- 3 And our care and share toy drive has been fantastic.
- 4 They really enjoy that.
- 5 And then of course, our Care 'n Share Toy Drive has just
- 6 been fantastic.
- 7 And of course, the exhibits department near and dear to
- 8 my heart.
- 9 This is what I started in here at the fair.
- And we had 21,000 entries from our community.
- 11 And this really is the only event where the community is
- 12 actually part of the show, where what they put on display is
- 13 part of what draws people to come and visit the fair.
- 14 These are just some photos.
- 15 This is from our art show.
- 16 This is our garden.
- 17 Design and wood exhibition.
- 18 We're extremely proud to have the diversity we offer and
- 19 have been recognized over the years for our diverse
- 20 programming and entertainment and one-day festivals.
- 21 We were actually asked to speak at fair conventions
- 22 because we do a fantastic job.
- 23 We have our Asian and Pacific Islander Festival.
- We have our Out At The Fair Festival.

- 1 And we added last year our Native American Powwow in the
- 2 arena.
- 3 We also have our Gospel Festival, which we've had for
- 4 many, many years.
- 5 It's very popular.
- 6 And this year, of course, we added our KPOP Festival.
- 7 And 4th of July is always a big deal.
- 8 We try to always make that a big deal at the fair.
- 9 Of course this year it will be on a Saturday, so I
- 10 anticipate it being a very big deal to a lot of San Diegans.
- 11 This is our 4th of July parade that we had down the
- 12 avenue.
- 13 And then we have a lot of  $4^{th}$  of July programming that we
- 14 offer.
- 15 And then of course, the world-famous fireworks we have
- 16 that evening.
- 17 And this isn't really a new thing but we kind of did it
- 18 in a new way.
- 19 After the fair everyone is like "where does the food go?"
- 20 Well, believe it or not, the vendors do go to others
- 21 fairs so they can use the food in other locations.
- 22 But they do have a lot of food and produce especially
- 23 that isn't going to make it to the next event.
- 24 So we worked with the San Diego County Food Bank and did

- 1 an official food recovery program.
- 2 Before they kind of, you know, found people they could
- 3 donate to and that sort of thing.
- 4 But we had a place where they could drop it off and then
- 5 we had made arrangements with the San Diego Food Bank to
- 6 actually come and pick it up at the end of the fair.
- 7 You can see the results there.
- 8 Albertson/Vons also donated out of their store that they
- 9 have on the concourse, they donated food from there.
- 10 It equaled about 2,800 meals that were donated at the
- 11 conclusion of the fair.
- 12 It was a great partnership and one we look forward to
- 13 continuing in the future.
- 14 Agriculture is a wonderful thing that we celebrate here
- 15 at the fair.
- 16 This is many fairgoers only exposure to agriculture all
- 17 year long because we live in such an urban community is here
- 18 at the fair.
- 19 So we take that responsibility, very, very seriously.
- 20 And it's one of the things that draws a lot of people to
- 21 come to our event.
- 22 This is one program out of many but this is our Junior
- 23 Livestock Auction we've had for over 50 years.
- 24 This year we raised \$664,000.

- 1 And all of that money goes to the youth programs that
- 2 participate FFA and 4H programs.
- 3 And those students will use the money to invest in other
- 4 projects.
- 5 So they learn how to become entrepreneurial and business
- 6 minded, but then they'll also use that money to ultimately pay
- 7 for their education as well.
- 8 We had 105 buyers.
- 9 Prices were higher than last year and we had a lot of
- 10 concessionaires participate which was really great to see them
- 11 getting into the action.
- I would encourage all of you if you haven't been in the
- 13 past just come spend an hour there.
- 14 It's really a lot of fun to watch a good old fashion
- 15 livestock auction.
- 17 KATIE MUELLER: Not quite that direct.
- 18 It went home with them.
- 19 Farm 2U is a brand-new exhibit.
- 20 This was the first brand-new exhibit from scratch aside
- 21 from the theme exhibit that we've done in a few years.
- 22 And so we did this exhibit on the east end of O'Brien
- 23 Hall, if you recall at all.
- 24 But basically it's a story of food from farm to the

- 1 table.
- 2 We had chefs and cooking demonstrations, we had
- 3 educational displays, we had a children's grocery store, we
- 4 had a meat market, so we had all kinds of displays.
- 5 Really geared towards all ages to learn about agriculture
- 6 in a unique way.
- 7 Now Tristan is going to come up and talk about marketing
- 8 and outreach.
- 9 But first, going to give you a little preview, not a
- 10 preview but a little news story that the Channel 8 had done
- 11 about our fair day at Rady's Children's Hospital.
- I know some of you were able to join us, but it was
- 13 really one of the most special things that I've been a part of
- 14 since I've worked here.
- 15 If we can get it to play.
- 16 And again.

- 9 TRISTAN HALLMAN: Well, the fair wasn't 29 days but we did
- 10 have I guess that was an extra day, that was one of our off
- 11 days but it was a tremendous team effort.
- 12 I know you were there and Director Barkett was there and
- 13 Director Blair as well.
- I think our only regret about it is that we weren't able
- 15 to have even more of our staff participate but even some of
- 16 the things that you saw there were the efforts our team that
- 17 wasn't able to attend due to health and safety protocols.
- 18 The ticket booth for example, those were things that were
- 19 set up by our team and so it's something we're very proud of.
- We didn't do it for the media.
- 21 And we're grateful that we had three, I think it was
- 22 about almost four minutes of TV time, which is a lot.
- 23 So we're grateful that we had that opportunity to tell
- 24 our story.

- 1 But we did have some intentional efforts to tell our
- 2 story as well, which was we had five media events this year.
- 3 This was the first time we've done some of these.
- 4 The first two you see there, and some of you participated
- 5 in that.
- 6 But we had our we've increased this from essentially
- 7 one media event to five now before the fair to increase our
- 8 media and get people's attention earlier in the cycle.
- 9 We focused on the different aspects of the fair as we
- 10 told our story.
- 11 We had our community event theme events.
- 12 We had our theme partnership event at the San Diego
- 13 Humane Society.
- 14 And then we did our Paddock Preview and we also went to
- 15 Tijuana beforehand.
- 16 And I do take objection to one thing Katie said.
- I was not fresh faced in that first photo.
- I had been up since 4:00 a.m.
- 19 here Media Morning, or I'm sorry, since 3:00 a.m., here
- 20 at 4:00 a.m.
- for that.
- 22 But it's a great opportunity to get people to come to
- 23 tell people about the fair before it opens.
- So we build all of our messaging and our storytelling

- 1 around a set of core messages each year.
- 2 And the first thing we always focus on is the thing we'll
- 3 talk about here in a minute is our theme.
- In a minute, I mean 2026.
- 5 It is the sort of central answer to the question we get
- 6 from media every single year at the fair, which is what is new
- 7 at the fair.
- 8 The theme always provides us an opportunity to bring new
- 9 things to the fair and new set of programming, ideas,
- 10 exhibits, et cetera.
- 11 So we did have a little bit of a challenge as Katie
- 12 mentioned with the celebration of pets but don't bring them.
- 13 We were successful in that this year.
- 14 We didn't have that many incidents of people actually
- 15 trying to do that.
- Value is a very important area for us not just because
- 17 we're telling people how they can save money.
- 18 We have a lot of deals.
- 19 But it's also about something else Katie said, which is
- 20 that bang for your buck.
- 21 Nowhere else can you get all of this for the price that
- 22 you're paying and essentially telling people it's worth it.
- This is a worthwhile experience.
- It's a can't-miss experience.

- 1 And it is going to be the most fun you can have in San
- 2 Diego in the summer.
- 3 Of course, the entertainment, the food, the fun that all
- 4 provides tremendous messaging value.
- 5 The Fair-Tastic Food competition was really big this in
- 6 its third year.
- 7 The tres leches cinnamon roll that we'll get to in a
- 8 minute.
- 9 Provided a lot of additional marketing opportunities for
- 10 us.
- 11 Summer tradition, of course, that's going to be part of
- 12 the messaging every single year where we focus on something
- 13 that people tell us they come back for, which is this is part
- 14 of what they do every summer in San Diego.
- 15 This is an event that dates back to 1880 and here since
- **16** 1936.
- 17 So that lineage, that tradition is something that we sell
- 18 every single year.
- 19 The community impact as well.
- 20 We really emphasized that early in the year with our
- 21 community banner program with the other kinds of community
- 22 impact and outreach programs that we do, Plant\*Grow\*Eat, et
- 23 cetera.
- 24 And then of course, that safe, inclusive event, that's

- 1 part of our messaging every year but it really came to the
- 2 forward this year because of the sort of fear and federal law
- 3 enforcement actions that were taking place right around the
- 4 time the fair started.
- 5 So we really emphasized that this was a place that people
- 6 could get away, that people were safe, that you could feel
- 7 included, that it was diverse.
- 8 That was just a way to tune out the outside world and
- 9 have fun with your community during the summer.
- 10 So this is just kind of a collection of headlines that
- 11 shows the effectiveness of the messaging.
- 12 You can see it kind of come through in the various
- 13 headlines.
- 14 I'm not sure if there are KPBS headlines in there, but
- 15 we'll work on it.
- 16 I'm kidding, Alex.
- 17 And it's not just about outreach to the media as well.
- 18 So we depend on our partners throughout San Diego County
- 19 to help us spread the word.
- 20 And one of the main ways we do that is through the
- 21 Community Banner, our Street Banner Program.
- 22 We've increased the number of participants every single
- 23 year.
- There's a limited number.

- 1 We're going to hit a point where we can't do anymore
- 2 because there's only so many street banners in San Diego.
- 3 But this is an opportunity for us to engage with people
- 4 directly, engage with organizations so we're able to take
- 5 their photo and advertise the fair and make them part of the
- 6 fair experience in a way maybe they don't have an exhibit but
- 7 they would like to be part of the promotion of the fair.
- 8 We also reached out to our local elected officials in a
- 9 new way this year.
- 10 Last year we did a series of proclamations at different
- 11 city councils.
- 12 This year we tried something new which was to reach out
- 13 to all of them and say, would you like to shoot some social
- 14 media video for us?
- 15 And we gave them prompts and directions.
- We had a number of people participating this year.
- We were very proud to see that.
- 18 I think Vivian Morano was the only one who actually
- 19 included her pet which was an option as well.
- We were glad to see that and really have an opportunity
- 21 to make our elected officials part of the fair experience and
- 22 part of the promotion for what we're doing.
- This was the first year we've done it.
- We hope to see it grow again next year as well.

- 1 And then some of those people actually came to the fair,
- 2 as well.
- 3 You see Mayor Gloria.
- 4 By the way, I love that this fair you can actually wear
- 5 sleeves in June.
- 6 But he came later in the fair to shoot video for his
- 7 social media accounts as well.
- 8 Great sport.
- 9 Congressman Levin came as well and met with some of us,
- 10 we talked about fairgrounds 2050.
- 11 Catherine Blakespear staff come and give us a ceremonial
- 12 recognition there on opening day.
- 13 You can see that picture over in the corner.
- 14 We had our usual Western Fairs Association member mixer.
- 15 That was about kind of showing up for the industry.
- And then our summer socials program, this was our third
- 17 year of doing it.
- 18 It's our second year with the format that we had it.
- 19 This was something when I got here that Carlene had a
- 20 vision for about bringing people into our space during our
- 21 biggest event of the year, the biggest summer party in San
- 22 Diego County.
- 23 And not only letting them experience the festive
- 24 atmosphere but being able to have an opportunity to share our

- 1 story and to share our plans and vision for the future.
- 2 So you see some of the groups that participated there.
- 3 This was the most participation we had.
- 4 We change the groups every year.
- 5 This was a great year for this.
- 6 And it gave us an opportunity to talk about our
- 7 fairgrounds 2050 plans as well.
- 8 You can see there are some photos there.
- 9 Down in the lower left-hand side corner, that is Chris
- 10 Cate, the San Diego Chamber President.
- 11 I believe it was his actual first event where he was
- 12 speaking and so he was able to come and do that as well.
- 13 But some of our board members obviously, thank you for
- 14 your participation in these events.
- 15 These are very important to us to be able to kind of get
- 16 our message out during our event and not just about corny dogs
- 17 and fried Oreos.
- 18 These are a look at some of our digital numbers.
- 19 You know, this changes every year.
- 20 We saw a lot of growth in our Facebook and Instagram
- 21 accounts this year.
- 22 We depend on influencers to help push out our content and
- 23 make it ubiquitous for people.
- 24 So digital advertising is something that we're shifting

- 1 more and more toward as traditional media becomes less and
- 2 less important.
- 3 It's important for us to be able to track all of these
- 4 statistics as well.
- 5 Something it's a little harder to do on television but
- 6 you are able to see direct response on these.
- We tried some new things around our customer experience
- 8 this year.
- 9 It is difficult to have 45,000 people with 1,200 new
- 10 employees, some of them are returning of course.
- 11 But really having messaging and training around how to be
- 12 able to ensure all of these guests, you know, when we do have
- 13 a busy day are having a great time.
- 14 So this year we tried some new things.
- 15 And I know I briefed you on this so I won't belabor it.
- But we combined some of our customer service units that
- 17 were in different parts of the fairgrounds.
- 18 So some were under the Public Safety Department, some
- 19 were under the Agriculture and Education Department.
- We made one Customer Care Unit.
- 21 We also understand that most people, unless they have a
- 22 problem, aren't going to those Customer Care representatives
- 23 necessarily unless they have a question.
- But we know they're interacting with our traffic and

- 1 parking staff, the ticket takers, the exhibit representatives.
- 2 So we really want to create a unified guide to how to do
- 3 customer service at the fair.
- 4 So this was our first year having sort of one coherent
- 5 message.
- 6 We had 20 tips that we're able to give out.
- 7 So we were able to emphasize one each day of the fair.
- 8 We gave it to them in advance.
- 9 We had provided everyone with guides.
- 10 We had a customer care pledge, so that was our outward
- 11 facing messaging about what you could expect.
- We had our code of conduct, which is also here's what we
- 13 expect of you.
- 14 And we provided safety lanyards to everyone to give a
- 15 quick reference guide to what you need to do in any sort of
- 16 emergency situation.
- 17 We also made it to where we only had one dispatch numbers
- 18 for facilities and public safety so that if there were issues
- 19 regarding spills, dirty bathrooms, or some sort of safety
- 20 issue, you call one number, you're able to have a facilities
- 21 dispatcher and we were able to respond to things much more
- 22 quickly this year through our newly established commander
- 23 center.
- We added more wayfinding, more maps, more QR codes that

- 1 were able to be used.
- 2 And we sent out a daily email survey to our guests, our
- 3 ticket buyers through sdfair.com.
- We weren't able to get the Albertsons/Vons ones, but the
- 5 ones who bought directly from through us, we were able to
- 6 email them every single day, so that was new this year.
- 7 And ask them just quickly, how was your experience.
- 8 And some of that feedback actually was very helpful.
- 9 After the first week, we saw we had a lot of people
- 10 saying your bathrooms are kind of dirty.
- 11 After that, our facilities department changed their
- 12 strategy and instantly we started seeing those complaints just
- 13 fall off the table.
- No one was complaining about bathrooms after the first
- 15 week.
- So that's the value of the kind of having these email
- 17 surveys each day.
- 18 Part of the customer experience of course is getting here
- 19 safely.
- We have limited on-site parking.
- 21 We had several days where we ran out of on-site parking,
- 22 and really needed to direct people to our off-site lots.
- 23 About 10% of our guests come through these off-site lots.
- So we saw a little bit of an uptick in Horsepark in

- 1 Solana Beach this year.
- 2 Canyon Crest, that's a little farther out, so we saw that
- 3 one was down.
- 4 But I think part of that could also be attributed to we
- 5 had more proactive messaging about the availability of our
- 6 lots this year so that people knew going in, if you go on
- 7 sdfair.com and you go on the traffic page, where there is
- 8 parking available.
- 9 We're going to push that out in the years to come.
- 10 But it was sort of a green, yellow, red system that I
- 11 think worked pretty well, especially during the second half of
- 12 the fair.
- Not much to say about safety.
- No major incidents.
- 15 We had almost a thousand Band-Aids for booboos, but other
- 16 than that, not really many issues.
- 17 So thank you to Mark and his team.
- 18 And you know, we had a good plan in place.
- 19 And I think the Command Center helped where people were
- 20 able to go in there and monitor cameras and situations and
- 21 there was instant response.
- 22 Putting this team together is a lot of work.
- 23 Katie mentioned not only do we have the 1,200 temporary
- 24 employees, she mentioned that we have the vendors, the

- 1 exhibitors.
- We have ride and game operators, we have sponsors onsite.
- 3 It takes a lot to pull all that together.
- 4 We're very proud that we're able to do that every single
- 5 year, but it is essentially thousands of people who help put
- 6 this on every single year.
- 7 Employee engagement for our employees, not only, and for
- 8 our vendors as well, communication is important.
- 9 We put out a daily email newsletter so that everyone
- 10 knows what is going on.
- 11 Try to make it as entertaining as possible.
- 12 But we also make efforts for our employees to reward them
- 13 for the work that they do.
- 14 It's a long fair.
- 15 It's 20 days.
- 16 Everyone is excited the first week.
- 17 Everyone starts getting a little tired the second and
- 18 third week.
- 19 And the we get the second wind in the fourth week.
- 20 But those, you know, when people start getting tired of
- 21 coworkers or being asked for the restroom is.
- 22 Keeping everyone engaged through our scavenger hunt,
- 23 through our various awards programs and rewards programs was
- 24 very effective this year.

- 1 And I think people liked it.
- 2 And now I'm going to have Katie come back up to talk
- 3 about fun stuff but I'll be back.
- 4 KATIE MUELLER: I'm glad I get the fun stuff.
- 5 All right.
- 6 Fair-Tastic Food Competition.
- 7 The reason that I bring this up or that I think it's
- 8 important to mention is we really have made a concerted effort
- 9 to position ourselves as a foodie fair.
- 10 Like you're going to get to come here and try food you
- 11 don't get to try anywhere else.
- 12 And we've worked really hard to choose vendors that
- 13 provide unique food items to pull out, you know, when
- 14 necessary some of the ones that maybe aren't stepping up to
- 15 our standards and that kind of thing.
- And one of the ways we do this is the Fair-Tastic Food
- 17 Competition, where we encourage vendors to enter unique food
- 18 items that they offer for sale to the general public as well.
- 19 And this is our third year of doing it in partnership
- 20 with San Diego Magazine.
- 21 They do a really nice spread about it.
- 22 And we have the judging live here the first day or two of
- 23 the fair.
- We always have room for judges, so if you haven't been a

- 1 judge yet, it's a great way to try all the new fair foods.
- This is a great partnership with our vendors.
- What we actually saw this year, these were our winners.
- 4 We offer three categories in sweet and savory classes.
- 5 But what we actually saw this year was an increase,
- 6 uptick in sales.
- We were able to actually monitor what people's sales are,
- 8 what items they are selling and that kind of thing.
- 9 We saw an uptick of the sales in a lot of the Fair-Tastic
- 10 food items.
- 11 But this was the overall winner and hopefully you got to
- 12 try it.
- 13 It was from the cinnamon roll stand right here at County
- 14 Fair on the concourse.
- 15 And their number one seller for 30 years was a good old
- 16 fashion cinnamon roll with frosting.
- 17 This year this surpassed that, their number one food
- 18 item.
- 19 That was pretty incredible just based on the social media
- 20 that came along with winning the competition.
- 21 And so here's a little snapshot of our judging.
- As you can fun was had by all.
- Our grandstand just to touch on that really quickly.
- Every year we're looking for a variety of genres to meet

- 1 the needs of a very broad and diverse audience.
- 2 Not counting our food and beverage sales at all in this
- 3 because that does play a huge part in all of our shows.
- 4 Our ticket revenue was over \$6 million, which by far
- 5 exceeds what our budgeted amount to spend was.
- 6 Our most popular in terms of the number of tickets sold,
- 7 Zedd and John Pardi, those were just both two winners.
- 8 And the only reason they weren't equal is because those
- 9 are a lot of single seats that are left over and those ones
- 10 are harder to sell.
- 11 Those were great, great shows if you attended those.
- 12 And then followed by Los Tucanes, which you know as I
- 13 mentioned earlier, probably would have been followed by some
- 14 of our other Hispanic acts.
- MS. MOORE: Just to clarify on that, because capacity for
- 16 us is?
- 17 KATIE MUELLER: About 79-8,000, somewhere in there.
- 18 That's all the tickets we can sell.
- 19 So that does come into play when bands are considering us
- 20 or we're making offers is that we only have a capacity of
- 21 about 8,000 at the max.
- 22 We did try some new sounds, I called them the variety
- 23 shows, at the -- I'm sorry, we did try some new shows at The
- 24 Sound.

- 1 I called them the variety shows because they were
- 2 nonmusical types of acts, laser shows, Cesar Milan.
- 3 Some of those.
- 4 This year, new this year, Belly Up, if you recall from
- 5 the summer meeting, Belly Up, if you recall from the summer
- 6 meeting, will be selling shows in the sound just like they do
- 7 year around.
- 8 We're really excited to be able to tap into that audience
- 9 that they draw regularly to The Sound.
- Just out of curiosity, one of our we are one of the
- 11 largest independent midways in the county.
- 12 There's only six in the entire United States.
- 13 And our rides and games contribute significantly to the
- 14 financial success of the fair, so it's extremely important
- 15 part of it.
- 16 These are the most popular rides.
- 17 I don't think there is probably any surprises here.
- 18 And then of course, the top five games.
- 19 And this is just an aerial shot from one of Mark Wilder's
- 20 shows on the avenue.
- 21 MS. MOORE: Mark Wilder who was featured.
- 22 KATIE MUELLER: Who was featured in the Channel 8 bit.
- Very popular entertainer.
- Some of our key takeaways.

- 1 You want to cover those?
- 2 DUSTIN FULLER: All right, so some of the key takeaways
- 3 before we get into the 2026.
- 4 Food draws.
- 5 And this is a credit as well to our vendors who
- 6 participated in these valued deals that we had the \$15 value
- 7 meals, the Foodie Friday.
- 8 And that's been big for us.
- 9 Consistently whenever you ask people why do you come to
- 10 the fair, food is going to rise to the top.
- 11 We had various layout changes that activated areas that
- 12 were previously sort of not particularly active I guess you
- 13 could say.
- 14 We brought more areas to life this year by changing some
- 15 of the layout.
- 16 The Command Center concept works.
- We'll look at maybe expanding that.
- 18 But that was a new idea that we brought to fruition this
- 19 year, combining our dispatch functions and customer care
- 20 functions into one space.
- 21 Genre variety matters of course.
- We want as many different offerings as possible.
- We really do try to offer something for everyone.
- Of course, some genres when we talk about grandstand

- 1 concerts don't do as well in the market.
- We do have, you know, the pet-themed activities were
- 3 popular this year as well.
- 4 So some of those we can carryover from year to year
- 5 beyond just the theme.
- 6 And then societal impacts.
- 7 They are hard to plan for but we have to be prepared for
- 8 things that happen outside the world affecting what happens
- 9 inside the fair.
- Just to go over.
- We sent a post-fair survey.
- 12 So in addition to the daily email surveys, we also sent
- 13 out a survey to our guests asking them about their experience
- 14 at the fair, This was much more comprehensive.
- The other one was only a few, quick questions so we could
- 16 get kind of the instant feedback, that touch point.
- 17 This was much more focused on the entire experience
- 18 people had.
- 19 We were very surprised and delighted to have received
- 20 almost 6,300 responses.
- Last year we got about 4,000.
- 22 And so we went through, we cast a wide net.
- Of course our biggest response rate is our emails but we
- 24 put it on social media and our website as well because we

- 1 wanted to capture people that didn't go to the fair this year.
- 2 So about 75% of those respondents said not only did they
- 3 attend the fair, they attend every single year.
- And by the way, this is different from our fairgrounds
- 5 2050 poll.
- 6 It's not scientifically significant.
- 7 It's not necessarily representative.
- 8 So all of those disclaimers.
- 9 These were people that were engaged enough to want to
- 10 answer our questions to at least haven opportunity to win some
- 11 tickets next year.
- 12 But nearly, more than 800 of the people that responded
- 13 said they didn't attend the fair this year, so that gives us a
- 14 useful data point as well.
- 15 Some of the take aways that we found interesting.
- 16 So, 60% of people said what we look at is when we look at
- 17 our ticket sales and it's usually online we see it, it's the
- 18 day before and the morning of essentially, or the day of.
- 19 That's when people tend to actually buy their tickets.
- When you actually ask people, very few of our tickets are
- 21 bought in advance of the fair.
- 22 When you actually ask people when did you decide you were
- 23 going to go?
- 24 They said January, February, March, they decide early

- 1 that they're going to go, they just don't buy until they are
- 2 ready.
- 3 Because we do sell tickets by day.
- 4 So repeat visitors were up.
- 5 We also had the season pass back this year, so that
- 6 probably contributed to that, so that's good at least among
- 7 this audience.
- 8 The top motivation people had for the date they selected
- 9 was their own availability.
- Not surprising.
- 11 It is summer in San Diego.
- 12 There's a lot to do.
- 13 There's a lot of plans that people have.
- 14 But it was their own availability.
- 15 Crowd size interestingly was a consideration of course.
- 16 We always hear people asking us 4th of July, that must be
- 17 so busy.
- I tell them, well, actually it's the 3rd of July, because
- 19 you all think it's the  $4^{th}$ .
- 20 And then the discount promotions we put a lot into that.
- 21 It was about for this crowd about 10% of the people said
- 22 that.
- That is significant of course but it's maybe not a
- 24 primary consideration for those people in terms of the date

- 1 they selected.
- 2 So we know people do come on the wristband days.
- 3 They come on Foodie Fridays.
- 4 That is not an unsizable chunk but something to consider
- 5 as we work on our messaging for next year.
- 6 People also love the general fair atmosphere.
- 7 That is a big reason that draws people when we ask them
- 8 why you come.
- 9 They just love the fair and everything we have to offer.
- 10 It's more than just the live music or the food, they just
- 11 love going to the fair and being at the fair.
- 12 It's a unique experience.
- And we actually had almost two-thirds, or I'm sorry,
- 14 almost three-quarters of our audience stays for more than five
- 15 hours or more.
- 16 That affects our parking of course, but it also, you
- 17 know, it's a good indicator that people like to spend time,
- 18 again, in that festive atmosphere.
- 19 When we talk about the value, that's why it's important
- 20 for us to note it's worth the experience and we do have ways
- 21 to save.
- 22 Tradition is a major driver for people.
- 23 As I mentioned before, that's one of our key selling
- 24 points.

- 1 I was really proud of this one because we focused a lot
- 2 on our navigation efforts this year, particularly our website.
- 3 Our website scored very, very high as a navigational
- 4 tool.
- 5 It's hard, you have to rebuild from scratch every year.
- 6 Essentially, we have the platform in place but we have to
- 7 enter all the events, we have to focus this year on cleaning
- 8 up our schedule to make it simpler and easier to understand,
- 9 including more entry points for maps and things like that.
- 10 The fact that it was really well regarded and that all
- 11 navigation tools were up 5%-9% over last year's survey, good
- 12 sign.
- 13 The top reasons that people didn't attend.
- 14 They said, you know, it didn't fit my budget or it didn't
- 15 fit my schedule.
- 16 That's going to be the case every year.
- 17 And then other reasons any number of other potential
- 18 reasons why people didn't come.
- 19 But those are the people that took the time to tell us
- 20 why they didn't come.
- 21 And yes, there is some stuff going on behind me.
- These are also, we asked some open-ended questions.
- 23 And it's important not to get lost in if you go on social
- 24 media and if you just hear people say this or that about

- 1 various aspects of the fair.
- 2 It's important to remember that most, that the vast
- 3 majority of people are having a great time.
- 4 And they actually did tell us that in this survey.
- We heard a lot more of that.
- 6 And so we were very happy to see some of these comments
- 7 there on the screen.
- 8 And that will close the book on 2025.
- 9 KATIE MUELLER: Yes, but --
- MS. MOORE: Let's pause there and take any comments or
- 11 questions from the Board.
- 12 DIRECTOR DeBERRY: I have a quick question.
- 13 So for you, Tristan, was there anything in the data
- 14 points that surprised you?
- 15 TRISTAN HALLMAN: I think one thing that surprised me was
- 16 the navigation tools going up.
- Obviously, we worked toward that but you just expect
- 18 people to complain sometimes.
- 19 A lot of times when you send people an online survey as
- 20 we saw in our daily email survey.
- 21 People will take the opportunity to complain about
- 22 anything they didn't enjoy.
- But anytime you see those numbers go up, it surprised me
- 24 in a good way.

- 1 DIRECTOR DeBERRY: Okay.
- 2 Thank you.
- MS. MOORE: Microphone.
- 4 VICE CHAIR BARKETT: It was Pet-tacular.
- 5 Am I saying it right?
- 6 And then I wanted to tell you that Hair of the Dog, the
- 7 speakeasy was just adorable.
- 8 That was really cute.
- 9 And I love how it was by The Sound so it kind of drew the
- 10 crowd that way too.
- I heard rave reviews about the speakeasies from all my
- 12 friends who went.
- 13 They love those too.
- 14 And it was just amazing.
- 15 So thank you.
- 16 DIRECTOR ARABO: I have a quick comment and question.
- 17 First, congratulations.
- 18 Great, great fair.
- 19 I want to thank Director Schenk who was the chair of the
- 20 committee.
- I worked with him on the committee.
- You were always there at every fair day opening and
- 23 ending.
- Thanks for everyone for your hard work.

- 1 Quick question for bottom line profit.
- 2 How much did the District make bottom, bottom line?
- I know you said in the beginning two-thirds.
- We're self-sustaining as an organization so it's
- 5 important that the number from the fair, how much is the net
- 6 profit, do we know?
- 7 MS. MOORE: I'll jump in here in terms of that.
- 8 So the -- there is, so there's profit before employee,
- 9 like the employee allotment of our full-time employees.
- 10 But the fair is, we had budgeted about \$12 million I
- 11 believe in terms of the profit on the fair.
- 12 And I believe my recollection is for this year's fair we
- 13 came in around 9 or 10 on that because we were down in some
- 14 areas.
- 15 While attendance was up, we were down in that paid
- 16 attendance.
- 17 We were down in those additional concert sales and there
- 18 is a ripple effect to it.
- 19 But by and large, we were within percentages of our goals
- 20 but overall and especially for something as large as the fair.
- 21 And then, I just don't recall because we also had some
- 22 savings on expenses related to the fair that helped to drive
- 23 that and we were just very cognizant of that throughout the
- 24 fair.

- 1 MR. RIVERA: Director Mead has her hand up.
- You can't see it in the collapsed windows.
- 3 DIRECTOR ARABO: My last comment was.
- I know Chair Nejabat created a new committee, hopefully
- 5 Director DeBerry will be the chair of it, for the Vendor and
- 6 Entertainment Committee.
- 7 So as before we get to the committee, I encourage the
- 8 staff not to lock in a lot of agreements yet until we get a
- 9 full review on what is the most impactful, what's the most
- 10 beneficial until we could bring a working item to the Board to
- 11 increase the minority owned, small business owned, women owned
- 12 and get more diversity into the ecosystem of the fair.
- 13 DIRECTOR MEAD: Hello?
- 14 CHAIR NEJABAT: Go ahead, Kathlyn.
- 15 DIRECTOR MEAD: Thank you.
- 16 First, I just want to also share my appreciation for
- 17 Chair Schenk and his work is ubiquitous at the fair.
- 18 It's just really a joy to see you on this last day, Fred,
- 19 along with Katie and the rest of the team.
- 20 Katie, you always do an amazing job.
- 21 But I especially want to thank you for the visit out to
- 22 Children's Hospital for those of uses who have been affiliated
- 23 with Children's Hospital and know the difficulty it is for
- 24 many of those children and families to actually get to the

- 1 fair, that was very special.
- 2 And I heard about that visit from many of my colleagues
- 3 and just want to thank you.
- I know it's not easy to take the show on the road.
- 5 And just much appreciation for doing that.
- 6 DIRECTOR SCHENK: Thank you, Kathlyn.
- 7 Being at Rady's with so many of us, it was really a
- 8 special afternoon.
- 9 I'm wearing my July 4th shirt today because I knew we
- 10 were going to have this presentation.
- 11 It's a wonderful way to celebrate the holiday to have
- 12 that communities out there.
- 13 As Tristan you pointed out, there were some challenges in
- 14 the community, but that day was a day that brought the entire
- 15 community together.
- 16 And toward the end of the run, that last Sunday really
- 17 brought out the Hispanic community in a way that made me feel
- 18 very proud and delighted.
- 19 This photo that we have up is a very small reflection of
- 20 a much larger team.
- 21 And Director Arabo there with his son is very meaningful
- 22 to me as well.
- 23 Representing multiple generations of this board.
- 24 And the last comment or the bottom comment of somebody

- 1 who said their favorite thing about the fair was the view from
- 2 the Ferris wheel being with family.
- I think it says it all.
- 4 Thank you to all of you who put it on.
- 5 DIRECTOR GELFAND: Yeah.
- 6 I would also like to congratulate staff on a really
- 7 incredible fair this year.
- 8 On one of one of the public outreach meetings for the
- 9 strategic plan that I attended, I talked to a guy who lives in
- 10 the community but has been a vendor at the fair for like 20
- 11 years.
- 12 He's retired so it's been 10 years since he did it, but
- 13 he said an interesting thing which is, there needs to be
- 14 communication between the vendors and the staff to make the
- 15 vendor experience better, which will make the fair better.
- 16 This new Entertainment and Vendor Relations Committee,
- 17 just as a suggestion you might want to set up a meeting before
- 18 or after the fair just to get feedback from the vendors to
- 19 help, you know, just make the following year's fair that much
- 20 better.
- 22 So the second part of what I was going to say is to
- 23 really acknowledge the two of you and certainly the entire
- 24 staff, Carlene, but definitely I have a bias between the two

- 1 of you, one from a communication's standpoint.
- 2 You always hit it right on the nail, you are phenomenal.
- 3 And I love the way that you do your outreach to the
- 4 communities at large.
- 5 And second, I just want to also acknowledge the diversity
- 6 of activities and the cultural richness and experience that
- 7 everyone no matter their background, who they are, could come
- 8 and find a piece of themselves and experience no matter what
- 9 it was.
- 10 So I just want to acknowledge that I feel like the fair
- 11 does an incredible job in making that happen.
- 12 That people from all over the world can come and find
- 13 themselves and experience their culture so thank you so much
- 14 for that.
- MS. MOORE: Thank you.
- So with that, moving onto the next.
- 17 KATIE MUELLER: As we turn the page, as we close the book
- 18 on 2025 and turn the page to 2026.
- 19 It didn't work.
- That transition.
- Yeah, it went fast.
- It was supposed to be like a book page turning.
- 23 Anyways, so our theme as was approved by the Board two
- 24 years ago, "Is Once Upon A Fair."

- 1 And our description: In a land not so far away, the story
- 2 of your San Diego summer begins.
- 3 And if you go to our website now, you will see this as a
- 4 landing page.
- 5 The San Diego County Fair is the greatest story our
- 6 community has ever told.
- 7 It's a tale of food, fun, friends, family, laughter,
- 8 tradition, music, amazement, and pure unbridled joy.
- 9 The fair, the biggest and longest running event in San
- 10 Diego County makes its triumphant return from Wednesday, June
- 11 10th through Sunday, July 5th, closed Mondays and Tuesdays.
- 12 In 2026, Once Upon a Fair invites our fair fanatics to
- 13 write a new chapter, one about the narratives that shaped us,
- 14 the simple pleasure of good books, the power or storytelling,
- 15 and all the magic found between the lines.
- We're really excited about this theme.
- 17 We started working on it actually over the summer even
- 18 before we brought out our partners from San Diego County
- 19 Library System and the San Diego Council on Literacy to come
- 20 out to the fair and see what we do with the theme, our theme
- 21 exhibit, and that kind of thing.
- We've also met with Dr.
- 23 Seuss Enterprises, Scholastic Book Fairs we've met with.
- 24 And we actually have a meeting with KPBS coming up in the

- 1 near future.
- 2 So lots of exciting things happening, parts moving.
- And we let nothing, you know, I can't remember the
- 4 saying.
- 5 No grass grow under our feet.
- 6 We are moving and it takes all of a year and more to plan
- 7 the next fair, so more to come.
- 8 More details.
- 9 So thank you all for your support of the fair and for all
- 10 of our team and we'll be back.
- MS. MOORE: Yes.
- 12 And I just on behalf of the entire team I have the joy
- 13 and privilege of leading this organization.
- I think it's understated in terms of the village that it
- 15 takes to produce the San Diego County Fair.
- 16 And your recognition that you've given to the staff of
- 17 that diversity that this place of belonging that we get the
- 18 privilege of creating each and every year and the team that is
- 19 behind that and the just ongoing nature of the work they do to
- 20 work to improve upon and debrief afterwards and get right into
- 21 planning for the next one.
- 22 Truly it is, it's those who aren't in this room today,
- 23 and I'm sure I speak on behalf of Katie and Tristan on this as
- 24 well, those who are not in this room today that really deserve

- 1 all of the accolades of the success and the joy that it brings
- 2 to our community.
- 3 On behalf of them, thank you very much for that.
- 4 And I too, just want to share my pride in them for just
- 5 again, just their creative minds, the logistics that they work
- 6 out.
- 7 There is so much that goes into producing something like
- 8 this.
- 9 DIRECTOR GELFAND: Yeah.
- 10 I would just like to say that although the revenue was a
- 11 bit off from the fair, we didn't talk about the Finance
- 12 Committee report, it's just referred to.
- 13 If you look at it we're actually doing really well
- 14 relative to budget because of cost savings.
- 15 And so I want to congratulate you on the ability to
- 16 respond when you saw things happening and keep us ahead of
- 17 budget even though revenues were off, and at the same time
- 18 pull off a really amazing fair.
- MS. MOORE: Thank you.
- 20 And it's that same village of people who helped make that
- 21 happen as well.
- 22 And we talked through it throughout the fair and what
- 23 could be done.
- So thank you for that.

- 1 CHAIR NEJABAT: Thank you both for that report.
- 2 And I'll echo everyone's statements on the job well done
- 3 to the team.
- 4 So with that, we'll move on to public comment for the
- 5 fair op's committee report.
- 6 Is there anyone in the room who wants to speak on this
- 7 topic?
- 8 No?
- 9 All right, that concludes public comment on this
- 10 information item.
- 11 Next up we have item 8C, the DMTC Liaison Committee
- 12 Report.
- 13 This is an information only item.
- 14 At this time I would like to recognize the committee
- 15 chair, Director Arabo, to provide the verbal report.
- 16 DIRECTOR ARABO: Thank you, Chair Nejabat.
- 17 I would like to recognize DMTC Josh Rubinstein is here,
- 18 if you want to come to the podium.
- 19 The committee met, Director Barkett, Vice President
- 20 Barkett and I met with Carlene and Josh.
- 21 The DMTC Committee met and we're so excited, grateful and
- 22 thankful for everything DMTC does.
- When I got on the committee a couple of years ago I told
- 24 him I want hopefully DMTC to be the safest race track, horse

- 1 race track in the country but also for it to be the most
- profit generating.
- Now we know it's \$10.2 million.
- I hope DMTC, the District makes more than that from your
- 5 operations and everything you do.
- 6 I think we're on par.
- 7 And we have the fall meet coming up.
- 8 Before that, we have very exciting the Breeders' Cup,
- 9 which is really, really remarkable event.
- 10 It's the super bowl of horse racing.
- I hope to see all my colleagues at the breakfasts and
- 12 events.
- 13 And it brings in around \$300 million in one weekend for
- 14 the region, and the District makes money.
- We're happy.
- 16 We're so grateful to the Breeders' Cup and grateful for
- 17 you, Josh, and your team and for DMTC.
- 18 So with that, I turn the floor to Mr. Rubinstein.
- 19 JOSH RUBINSTEIN: Thank you, Director Arabo.
- 20 And good afternoon, district directors and staff.
- Josh Rubinstein with the Del Mar Thoroughbred Club.
- 22 As Director Arabo said, the Breeders' Cup is almost here,
- 23 just 17 days away, which is really exciting.
- If you've been around the facility at all, the

- 1 implementation of chalets and temporary track side boxes is
- 2 well underway.
- 3 The City of Del Mar has the famous Breeders' Cup purple.
- 4 So you can really feel that the event is coming.
- 5 Look, you've heard us report on this before, having the
- 6 Breeders' Cup is a real honor.
- 7 And Del Mar hosting the World Championships four out of
- 8 nine years is not something to be taken for granted.
- 9 As Director Arabo mentioned, the Breeders' Cup provides
- 10 significant revenue to the District and a huge economic boost
- 11 for the local community.
- 12 The Breeders' Cup is part of our five-week fall season,
- which opens on October 30th.
- 14 We open on Thursday the 30th and then the Breeders' Cup
- 15 begins on Friday, October 31st.
- And we have some real positive momentum from the recently
- 17 concluded summer meet.
- We saw gains in attendance, wagering, and food and
- 19 beverage.
- We're very optimistic about the upcoming fall season and
- 21 of course the Breeders' Cup.
- 22 Happy to answer any questions.
- DIRECTOR ARABO: Any colleague on the Board want to ask
- 24 DMTC any questions?

- 1 I have a question, Josh.
- 2 We've done such a great job securing Breeders' Cup four
- 3 out of the last nine years, which was really a great
- 4 accomplishment.
- 5 How do you see or what can we do as far as upgrades
- 6 specifically for the DMTC and the facilities to attract
- 7 another Breeders' Cup?
- 8 One or two, think of a wish list of what we could do to
- 9 attract Breeders' Cup again and increase revenue for the
- 10 District, what would it be?
- 11 JOSH RUBINSTEIN: The Breeders' Cup is very much about the
- 12 customer experience.
- 13 And Director Arabo, as you saw earlier this year, and
- 14 Director Barkett, when we went to Keeneland, they have
- 15 undergone a \$150 million paddock renovation, which is
- 16 something that is very attractive to the Breeders' Cup because
- 17 it's more premium seating and also it adds to the overall
- 18 customer experience.
- 19 In 2027, the event will be going to New York at a brand-
- 20 new Belmont Park.
- 21 Cost of over \$500 million to build.
- 22 So look, we have a beautiful facility here.
- 23 It was built in 1991.
- We are fortunate to have a significant amount of high-end

- 1 space.
- 2 That's one of the reasons why the Breeders' Cup likes
- 3 coming here because all of our suites and sky rooms.
- 4 But if you ask me to pick probably one improvement, I
- 5 would say they are our video boards.
- 6 And I think as anyone who attends a sporting event or
- 7 even a concert these days, people tend to focus more on video
- 8 screens than they do the live action.
- 9 And our boards are over 10 years old.
- 10 So I guess if you gave me a wish list, at the top of that
- 11 would be new video boards facing the grandstand and in the
- 12 paddock.
- 13 DIRECTOR ARABO: Okay.
- 14 Vice President Barkett?
- 15 VICE CHAIR BARKETT: I would agree with that only because
- 16 I heard that mentioned from friends that go to the concerts.
- 17 They say you need new screens.
- That's all I keep hearing.
- 19 Bigger, more visual, better technology, and so I think
- 20 that goes hand in hand.
- 21 And it would be useable for all here.
- JOSH RUBINSTEIN: Yeah, and we're seeing that with new
- venues across the country.
- If anybody has been to SoFi or the Intuit Dome where the

- 1 Clippers play in Los Angeles, you walk into to those venues
- 2 and you're blown away by the screens.
- 3 DIRECTOR ARABO: I've said it before, there's a general
- 4 rule in business, 80/20 principle where 20%, 80% of revenue
- 5 comes from really 20% of the activities.
- 6 And in the District it's really the horse racing and the
- 7 fair.
- 8 And so it's important for us to invest in an investment
- 9 that could yield back money for the District because we are
- 10 self-sustaining.
- 11 But hopefully you'll come to the committee with numbers
- 12 and figures and for a Board consideration.
- JOSH RUBINSTEIN: We'd be happy to do that.
- 14 Thank you.
- 15 DIRECTOR ARABO: Any other Board directors comments or
- 16 questions?
- 17 DIRECTOR DeBERRY: So I have one question for you, Josh.
- 18 When you think about the experience, the Breeders' Cup or
- 19 any other race, right, what do you have something or thought
- 20 in your mind of how we can generate or increase that
- 21 experience?
- 22 Like so once the race ends at whatever time it ends,
- 23 right, 6:00, what else can we do to kind of expand that
- 24 experience here within the fairgrounds?

- 1 JOSH RUBINSTEIN: That's a great question and something
- 2 that we discuss a lot internally.
- 3 Of course, now with The Sound here there has been
- 4 discussion of having a post Breeders' Cup event at The Sound.
- 5 Unfortunately, I don't think the Breeders' Cup was
- 6 comfortable with the talent that they could attract for that
- 7 event.
- 8 But that is something not just for the Breeders' Cup but
- 9 also from our standpoint from live racing during the summer
- 10 and fall we have this great venue, The Sound.
- 11 We look forward to working with the District staff on
- 12 ways that we can keep folks here and transition them to a new
- 13 entertainment experience at The Sound.
- 14 DIRECTOR DeBERRY: Thank you.
- 15 VICE CHAIR BARKETT: I love that idea.
- 16 And you know, there were two days that weren't booked at
- 17 The Sound this year that were anticipated to and that loss of
- 18 revenue is really crucial.
- 19 I think the more we can combine and look for those extra
- 20 concerts while they are here in place, I think it would be
- 21 very popular.
- Thank you.
- 23 CHAIR NEJABAT: Any other questions?
- MR. RIVERA: We have Director Mead has her hand up.

- 1 CHAIR NEJABAT: Director Mead.
- 2 DIRECTOR MEAD: Thank you.
- 3 Thank you for your presentation, Josh.
- 4 And I just want to state again, you and I have chatted
- 5 about this.
- I know it's very difficult to coordinate and expensive to
- 7 run but there were several years ago when we had post-race
- 8 concerts on I think they were the Friday nights events.
- 9 And I continue to hear that from my friends and
- 10 colleagues about having the Friday night concerts, whether
- 11 they are on the grandstand.
- I don't think my memory is that they were in the
- 13 grandstand.
- But I do think that people told me those were the days
- 15 they came to the fair were the days, I mean, excuse me, not
- 16 the fair the races, were the days the concerts came out.
- 17 And it was a great way to turn Friday afternoon into a
- 18 race day and into the evening.
- 19 So I'll just share that again with you publicly.
- 20 JOSH RUBINSTEIN: Thank you for those comments, Director
- 21 Mead.
- 22 And I think that's fits very well into the discussion we
- 23 look forward to having with district staff and the Belly Up on
- 24 the concerts at The Sound after the races.

- 1 CHAIR NEJABAT: All right.
- 2 Thanks, Josh.
- 3 JOSH RUBINSTEIN: Thank you.
- 4 CHAIR NEJABAT: All right.
- 5 Moving on.
- 6 Do we have anyone from the public in the room who wishes
- 7 to speak on this topic?
- If so, please queue up.
- 9 All right, seeing none.
- 10 We'll move on to the Zoom speakers.
- 11 We'll start off with Jane Cartmill.
- 12 You have two minutes as a reminder.
- 13 JANE CARTMILL: The following is from the Association of
- 14 Racing Commissioners International, was published in Blood
- 15 Horse on October 3<sup>rd</sup>, 2025.
- 16 Quoting, an independent assessment of the Horse Racing
- 17 Integrity and Safety Authority, HISA programs, raises
- 18 questions as to whether the results justify the almost \$230
- 19 million cost that will have been spent on the authority by the
- 20 end of 2025.
- In the 19 states regulated by HISA since 2022, the equine
- 22 fatality or ran rate remains largely unchanged except for
- 23 minor variations.
- There are few anti-doping tests being done, no new doping

- 1 agents detected, and \$165 million in new fees being assessed.
- 2 Neither the Federal Trade Commission, General Accounting
- 3 Office, or any congressional panel has performed a review of
- 4 how HISA programs are actually working.
- 5 This assessment is the only that currently exists.
- 6 It is based on publicly available data and limited in
- 7 that HISA maintains they are not subject to open meetings or
- 8 public records requests consistent with the Federal Advisory
- 9 Committee Act.
- 10 CHAIR NEJABAT: Thank you for your comments.
- 11 Martha Sullivan.
- 12 MARTHA SULLIVAN: Hello.
- 13 This is Martha Sullivan, again, from Imperial Beach.
- 14 This Thursday morning, the California Horse Racing Board
- 15 will discuss quote, the future of challenges facing horse
- 16 racing in California, end quote.
- 17 Along with the continuing drop in wagering handle,
- 18 including at Del Mar.
- 19 The continuing drop in the horse population is a big
- 20 challenge.
- 21 Last week, the Jock Club released the 2025 report of
- 22 North American mares bred with a decline of 6.4% from 2023.
- 23 If Kentucky has 66% of the 2025 mares bred.
- The second largest breeding state is California.

- 1 With only 5.1% of the 2025 mares bred, down 20% since
- 2 2023 at 270 mares bred in 2025.
- In a story titled, quote, "Horse racing faces major
- 4 threats in Florida, California," end quote.
- 5 USA Today reported on these challenges in May, quoting
- 6 Damon Thayer, the retired Kentucky state senator, now advising
- 7 a group called the thoroughbred racing initiative.
- 8 Quote, "The biggest challenge in California is antipathy
- 9 from race track owner Belinda Stronach, for the sport,
- 10 antipathy from legislators in Sacramento, and antipathy from
- 11 the Native Americans who control the casino industry.
- 12 I don't think any of them care about the future of horse
- 13 racing in California.
- 14 And if California racing is going to survive and thrive,
- 15 particularly at Santa Anita Park, somebody in those groups is
- 16 going to have to start to care, " end quote.
- 17 This is the state of California horse racing.
- 18 Take your blinders off.
- MS. O'LEARY: Ms. Sullivan, your time is up.
- 20 CHAIR NEJABAT: Thank you for your comments.
- 21 And that wraps up public comment on this topic.
- 22 Next up, we have item 8-D, which is consider
- 23 consideration and vote to amend policy 6.01, of the event
- 24 ticket policy to add a section predicting there

- 1 disproportionate use of tickets or passes by any 22nd DAA
- 2 official.
- 3 This is an action item.
- 4 You can find the report beginning on page 21 of the
- 5 packet.
- 6 We will now move onto public comment.
- 7 Do we have any members of the public who wish to speak on
- 8 the ticket policy amendment?
- 9 Anyone in the room?
- 10 No?
- 11 Seeing none online.
- 12 That concludes the public comment.
- 13 At this time, I'll entertain a motion.
- 14 VICE CHAIR BARKETT: So moved.
- 15 CHAIR NEJABAT: Second?
- 16 DIRECTOR ARABO: Second.
- 17 CHAIR NEJABAT: Second, Director Arabo.
- 18 Thank you.
- 19 Any discussion from the motion from our board?
- 20 All right.
- 21 Seeing none.
- 22 Can we get a roll call please for the vote.
- MS. O'LEARY: Chair Nejabat.
- 24 CHAIR NEJABAT: Aye.

- 1 MS. O'LEARY: Vice Chair Barkett.
- 2 VICE CHAIR BARKETT: Aye.
- MS. O'LEARY: Director Arabo.
- 4 DIRECTOR ARABO: Aye.
- 5 MS. O'LEARY: Director DeBerry.
- 6 DIRECTOR DeBERRY: Aye.
- 7 MS. O'LEARY: Director Gelfand.
- 8 DIRECTOR GELFAND: Reluctantly, aye.
- 9 MS. O'LEARY: Director Mead.
- 10 DIRECTOR MEAD: Aye.
- MS. O'LEARY: And Director Schenk.
- 12 DIRECTOR SCHENK: Aye.
- 13 CHAIR NEJABAT: All right, the motion carries.
- Moving onto item 8-E, which is consideration and vote to
- 15 approve the 2026 Board of Directors meeting schedule.
- This is an action item, so we'll start with any public
- 17 comment.
- 18 Any members of the public who wish to speak.
- 19 Seeing none.
- That concludes public comment.
- 21 At this time, I'll entertain another motion.
- VICE CHAIR BARKETT: So moved.
- DIRECTOR ARABO: Second.
- 24 CHAIR NEJABAT: Second, Director Arabo.

- 1 Any discussion?
- 2 All right, seeing none, can we get another roll please?
- 3 MS. O'LEARY: Chair Nejabat.
- 4 CHAIR NEJABAT: Aye.
- 5 MS. O'LEARY: Vice Chair Barkett.
- 6 VICE CHAIR BARKETT: Aye.
- 7 MS. O'LEARY: Director Arabo.
- 8 DIRECTOR ARABO: Aye.
- 9 MS. O'LEARY: Director DeBerry.
- 10 DIRECTOR DeBERRY: Aye.
- MS. O'LEARY: Director Gelfand.
- 12 DIRECTOR GELFAND: Reluctantly, aye.
- MS. O'LEARY: Director Mead.
- 14 DIRECTOR MEAD: Aye.
- MS. O'LEARY: And Director Schenk.
- 16 DIRECTOR SCHENK: Aye.
- 17 CHAIR NEJABAT: All right.
- 18 The motion carries.
- 19 Moving onto item 8-F, a discussion and vote on whether to
- 20 direct staff to work with the City of Del Mar to amend the
- 21 Exclusive Negotiating Rights Agreement entered into between
- 22 the District and the City of Del Mar.
- You can find the written report on this item beginning on
- 24 page 35 in your packet.

- 1 Additionally, board members should have received an email
- 2 last night, via email.
- 3 This was also included into your binders today and added
- 4 to our website.
- 5 Before you get to public comment on this item, we have a
- 6 report from our CEO, Carlene Moore and Deputy Attorney
- 7 General, Josh Caplan.
- 8 MS. MOORE: And I will just be very brief in this since I
- 9 updated you under my executive report with regard to the
- 10 status of things with the City of Del Mar.
- 11 And again those various studies the due diligence is
- 12 underway under the HAP grant, so hopefully everybody had an
- 13 opportunity to read the information that was provided
- 14 including last night's supplement.
- 15 It is, I just want to confirm that it is posted on our
- 16 website.
- 17 That we were able to post that yesterday evening.
- 18 And so with that, I will hand over to our Deputy Attorney
- 19 General, Josh Caplan.
- MR. CAPLAN: Thank you, Carlene.
- 21 And I'll try to keep my comments direct.
- 22 And I typically don't speak on agenda items but I was
- 23 invited to remind the Board of the contents of the ENRA, the
- 24 genesis of that agreement.

- 1 And hopefully that will help guide the Board's
- 2 discussion, whether to take any further steps regarding that
- 3 agreement.
- 4 So as some of you who are on this board may remember,
- 5 this agreement was approved 18 months ago by this board after
- 6 ongoing discussions with the City of Del Mar regarding this
- 7 working agreement.
- 8 The agreement has a term of 24 months with up to two,
- 9 six-month extensions.
- 10 Which again, this board is part of this agreement vested
- 11 in the CEO the authority to extend this agreement again up to
- 12 a full 12 months.
- So if both six-month options are exercised then the full
- 14 life of the ENRA would be 36 months or three years.
- A few pieces that I want to just remind the Board of.
- 16 The ENRA is not a lease agreement.
- 17 It's not -- it doesn't even require this board to approve
- 18 a lease agreement.
- 19 It simply requires good-faith negotiations with the City
- 20 of Del Mar.
- 21 Good-faith negotiations on a number of topics, including
- 22 making preliminary feasibility determinations on appropriate
- 23 sites for affordable housing development, identifying options,
- 24 again, on the property for those sites.

- 1 Defining the scope of what a potential affordable housing
- 2 development would look like.
- 3 And ultimately, if an affordable housing development is
- 4 determined to be feasible on the property, then to negotiation
- 5 with the City of Del Mar on a potential lease agreement.
- 6 Again, and I think this is critical because there's been
- 7 some misstatements in the public sphere on the scope of this
- 8 agreement.
- 9 Again, it does not obligate this board to enter into a
- 10 lease agreement with the City of Del Mar.
- 11 And this agreement in several places I think provides a
- 12 reminder of that.
- 13 And you all have the agreement in front of you.
- I'm sure you've all read it several times but you can
- 15 look to recital "N," which is an express acknowledgment that
- 16 the agreement itself does not obligate any party to acquire or
- 17 convey any portion of the property or to grant the city the
- 18 right to develop affordable housing at the facility.
- 19 There's other provisions too that echo that same
- 20 narrative.
- 21 Section 1.2 and section 3.1.
- 22 And ultimately after all these feasibility studies
- 23 determinations are made and the Board has had a chance to
- 24 review the studies that are going to flow from this process,

- 1 this board has the ultimate authority to decide whether or not
- 2 in terms of the Master Site Planning process, that they are a
- 3 good fit for the affordable housing.
- 4 But at this point, it's really a study period for you all
- 5 to get as much information as you can to help frame that
- 6 discussion.
- 7 Whether that happens at the end of an option period or at
- 8 the end of the full duration of the ENRA term.
- 9 The last thing I want to remind the Board and we've seen
- 10 this over the last couple of meetings, is this board, the
- 11 jurisdiction of this board is really within the development
- 12 and the decision is on its own property.
- 13 The Food and Ag Code is pretty clear if you look at
- 14 Section 4051.
- 15 This board has ultimate authority with the approval by
- 16 DGS to make any decision about leasing or selling portions of
- 17 its property, including for the lease for the development of
- 18 affordable housing with some time constraint limitations.
- 19 I think under the current statute, if you all decide to
- 20 enter into a lease agreement, it could be no more than 55
- 21 years.
- 22 But again, that's the authority of this board, right, is
- 23 to make decisions about what to do with this property.
- 24 And so again, I'm just going to remind the Board that

- 1 it's not within the jurisdictional purview of this agency to
- 2 opine on or have any discussions about the development of
- 3 property outside of the 22nd DAA.
- 4 So if board members want to bring up discussions about
- 5 development within the city but outside of the perimeter of
- 6 this properties, I would likely object because that's within
- 7 the purview of other jurisdictions and not the 22nd DAA.
- 8 To the extend board members think it's appropriate to
- 9 have those discussions when you're negotiating a lease, for
- 10 example, to determine a fair market value, then we'd have to
- 11 consider and be sure that you all are acting within your
- 12 jurisdiction.
- Again, we need to be sure that this agency isn't
- 14 interfering with or frustrating or even getting itself
- 15 involved with discussions that do not directly relate to the
- 16 development of your property.
- 17 So I guess with that, I will turn it back over to Chair
- 18 Nejabat to begin the process, unless there's specific
- 19 questions.
- 20 MS. MOORE: One thing to add, which you touched on a
- 21 little bit, Josh.
- 22 But when we were negotiating this agreement, the
- 23 Exclusive Negotiating Rights Agreement that we have, one of
- 24 the messages of this board and I think that is what is found

- 1 in this document was we need, so the city has its timeline
- 2 with regard to its sixth cycle housing element, but it was
- 3 important for us to maintain the integrity of what we need,
- 4 what this board collectively needs in pursuit of our Master
- 5 Site Plan and maintaining that flexibility.
- 6 So therefore we were -- it was very important to not be
- 7 bound through this ENRA and really providing for that
- 8 treatment but also for it to match up to our timeline.
- 9 So at the time when we entered into this agreement, the
- 10 thought was, Master Site Plan in a couple of years.
- 11 And so hence, because of the process that we have taken,
- 12 right, this extensive public outreach that we have engaged in,
- 13 which has really taken us through 2025.
- 14 That's where we extended the options, I want to make sure
- 15 I was using the right term.
- 16 The options on that so that better aligns with our Master
- 17 Site Planning work.
- 18 Really those decisions being driven by us as the
- 19 District.
- 20 So that's what we worked to really create in this
- 21 document Was that flexibility and owning the timeline that
- 22 benefited our timeline of the Master Site Plan.
- 23 DIRECTOR GELFAND: I need a little more understanding of
- 24 what we can and can't talk about and why.

- 1 Because part of our decision to entertain this in the
- 2 first place 18 months ago was the City of Del Mar's concerns
- 3 about meeting their RHNA guidelines.
- And so, are you saying we can't take that into
- 5 consideration in our --
- 6 MR. CAPLAN: The answer, Director Gelfand, is yes, you
- 7 can.
- 8 Because that's really specific to your decision to house
- 9 affordable housing units on this property based on discussions
- 10 with or at the request of another jurisdiction.
- 11 My caution was really about conditioning your all's
- 12 approval or consideration of the city's request on the city's
- 13 decision related to other development projects outside of the
- 14 of the fairgrounds.
- 15 Because there was a focus at the last public meeting
- 16 [multiple speakers] -- in particular, pressing the city on
- 17 pending permits for other potential projects within the city.
- 18 It's those discussions that are entirely unrelated to
- 19 discussions with the city about development projects here at
- 20 the 22nd DAA.
- 21 Those projects that are outside of the fairgrounds
- 22 property line are the discussions this board needs to avoid.
- DIRECTOR GELFAND: Okay.
- 24 And what about the city's apparent effort to change the

- 1 RHNA guidelines themselves so that their need for affordable
- 2 housing may diminish?
- 3 MR. CAPLAN: Well, I think that can be part of your
- 4 ongoing discussions with the city.
- 5 DIRECTOR GELFAND: Okay.
- 6 MR. CAPLAN: Whether and to what extent.
- 7 So that certainly would be appropriate here because
- 8 that's going to guide this board at some -- maybe not today
- 9 but if you get to the point where you determine that there's a
- 10 particular site that is appropriate and you're trying to
- 11 determine the scope of that site, how many units, certainly,
- 12 the city will probably provide you information on their
- 13 request if that request changes, if they need fewer units or
- 14 more units that certainly can be something this board can
- 15 consider.
- 16 DIRECTOR GELFAND: Could we take some kind of position to
- 17 support or encourage that process that the city is
- 18 undertaking?
- 19 MR. CAPLAN: The process the city's undertaking to?
- 20 DIRECTOR GELFAND: Change the RHNA guidelines.
- MR. CAPLAN: Potentially to reallocate.
- MR. CAPLAN: The assessment of the number of affordable
- 24 housing units they need to come up with during the sixth

- 1 cycle.
- I think the District should probably stay neutral on that
- 3 at this point.
- 4 Because again, I mean to the extent you all disagree with
- 5 the city, that disagreement can be raised in the context of
- 6 your negotiations with the city in terms of the number of
- 7 units here, right.
- 8 So if you all think that the city should be pushing for a
- 9 lower number, then as part of the negotiations with the city,
- 10 you can certainly say, you know, while we're going to pursue
- 11 affordable housing as a board, we think it's probably more
- 12 appropriate for us to consider some number of units less than
- 13 61 or whatever the number is that the city has requested from
- 14 the 22nd DAA.
- 15 That is within your authority.
- 16 I just -- I would be concerned with the Board getting
- 17 involved with or lending support one way or the other on the
- 18 city's efforts in their discussions with another state agency
- 19 because that will have implications for the city, not just for
- 20 their affordable housing units that they're requesting to be
- 21 housed here, but for their requirements citywide.
- 22 And it may also have impacts on other potential
- 23 development projects that we need to try and stay out of that
- 24 process because we don't want to get in the middle of

- 1 discussions or ongoing litigation or disagreements between the
- 2 city and other developers based on some change in that number.
- 3 DIRECTOR GELFAND: And that would include SANDAG?
- 4 MR. CAPLAN: Yes.
- 5 DIRECTOR GELFAND: Okay.
- 6 Thank you.
- 7 CHAIR NEJABAT: Any other questions?
- 8 DIRECTOR ARABO: Yeah, I have a point of clarification for
- 9 Josh.
- 10 I think you mischaracterized the last meeting in the
- 11 sense that I don't see the Board or myself looking at the city
- 12 what they are doing in their city as far as what they look at.
- 13 Actually was pretty much if you look at the minutes, we
- 14 have somebody who types them up, was very specific in that.
- 15 That's saying that that's Del Mar's business, that's not
- 16 our business.
- 17 The point was the theme of using the District as an
- 18 excuse not to hit that number.
- 19 Because the former President Schenk made the comment of
- 20 the data and the basis that they were using was flawed.
- 21 And that is again, with the lens of what is best were the
- 22 District, not what any city does in any part of their city
- 23 because that's none of our business and I don't think anyone
- 24 thinks it's their business.

- 1 I want to make that point very clear so it's on the
- 2 minutes that I didn't see anyone on this board thinking about
- 3 what the city is doing in their jurisdiction.
- 4 CHAIR NEJABAT: Anyone else?
- 5 All right.
- 6 With that, we'll now hear public comment.
- 7 Do we have any members of the public who wish to speak on
- 8 this item?
- 9 Please queue up at the podium.
- 10 A reminder, two minutes.
- 11 LAURA DE MARCO: Hi, my name is Laura De Marco.
- 12 And Director Arabo, I was intimately involved in
- 13 critiquing the RHNA allocation numbers.
- 14 And I went to SANDAG and a number of people did to
- 15 basically say that the numbers that SANDAG had calculated were
- 16 erroneous because they looked at jobs specifically in the
- 17 92014 area code and they did not exclude part-time jobs,
- 18 seasonal jobs.
- 19 And from that they captured all the part-time seasonal
- 20 workers that you guys hire for the fairgrounds, people that
- 21 come down from L.A.
- and Orange County with the race track.
- 23 So they ended up calculating more jobs in Del Mar than
- 24 our entire population.

- 1 Okay, so you know, that really stood out.
- The City of Coronado did the same thing.
- 3 They counted all the guys out on the ships that don't
- 4 actually reside in the City of Coronado.
- 5 They're in the barracks.
- 6 They're on shipboard.
- 7 I mean, they don't need more housing.
- 8 But we all lost.
- 9 The City of Coronado sued SANDAG, they lost.
- 10 And the problem is the sixth cycle RHNA numbers, we're
- 11 stuck with them.
- 12 They are permanent.
- We can't get around it.
- 14 So that is the dilemma that the City of Del Mar is in.
- 15 This is a state mandate.
- 16 You have housing on this fairground's property that is
- 17 substandard, speaking for the Hispanics, that part of my
- 18 family that works in the stable areas.
- 19 It would be great, you could have the opportunity to
- 20 upgrade that as well as provide affordable housing.
- 21 And if you look at the medical profession, all the
- 22 professionals in the Del Mar and Solana Beach area --
- MS. O'LEARY: I'm sorry but your time is up.
- 24 CHAIR NEJABAT: Thank you.

- 1 Thanks for your comments.
- 2 DARREN PUDGIL: Good afternoon, Chair Nejabat and members
- 3 of the board.
- 4 My name is Darren Pudgil.
- 5 And I'm here on behalf of Seaside Ridge, the proposed
- 6 mixed-income community that would be built just across Camino
- 7 del Mar.
- 8 It was three years ago today on this very day that we
- 9 submitted our application to the City of Del Mar.
- 10 Sadly, three years later, it's no closer to becoming a
- 11 reality due to the city's inaction.
- 12 Unfortunately, since your meeting last month, the Del Mar
- 13 City Council voted to block our project while continuing to
- 14 rely on you to solve their housing problems.
- 15 With 85 affordable units including 42 low-income units,
- 16 the ready to go Seaside Ridge proposal would significantly and
- 17 much more quickly help the city comply with state housing laws
- 18 and bring much needed, low-income housing to Del Mar and to
- 19 our region.
- 20 The need for affordable housing today is greater than
- 21 ever.
- 22 According to the San Diego Housing Federation, San Diego
- 23 County is 134,000 homes short for low-income renters.
- 24 And our governor has made it very clear, every city must

- 1 do its part to solve the housing crisis.
- 2 How many low-income units does Del Mar have?
- None.
- 4 How many building permits has the city issued for low-
- 5 income housing?
- 6 Zero.
- 7 By turning away a real project like Seaside Ridge, Del
- 8 Mar isn't helping to solve anything.
- 9 In fact, they are part of the problem.
- 10 Unfortunately, they seem to like paper projects,
- 11 conceptual ones like the one here at the fairgrounds a lot of
- 12 more than those that are ready to go.
- 13 Ultimately, the fate of Seaside Ridge will now be
- 14 determined by a judge.
- 15 What you have to ask yourselves is whether a city with a
- 16 long history of resisting affordable housing can be trusted to
- 17 actually move these units forward.
- 18 All this comes as the City of Del Mar City Council
- 19 battles Governor Newsom and his pro-housing agenda by
- 20 unanimously endorsing a statewide ballot measure that would
- 21 undo everything he's trying to accomplish.
- This action should tell you what their real goal is.
- Thank you.
- 24 CHAIR NEJABAT: Thank you for your comments.

- 1 BROOKE MILLER: Brooke Miller, counsel for Seaside Ridge.
- 2 And I want to give you some context as to why we're here
- 3 today talking to you about the ENRA.
- 4 The city is using the ENRA to avoid rezoning the Seaside
- 5 Ridge project site to accommodate the project by rate.
- 6 It's doing this by claiming that the ENRA satisfied its
- 7 obligation under its housing element program 3A to enter a
- 8 binding agreement with the state to develop housing on the
- 9 fairground's property.
- 10 Under a different housing element program, program 1E,
- 11 the city would rezone the project site, the Seaside Ridge
- 12 project site, only if it fails to meet project program 3A.
- In other words, they need your land to satisfy their
- 14 preferred location for affordable housing.
- 15 But as your staff report and your counsel has
- 16 acknowledged, only this board can decide whether to make a
- 17 binding commitment to develop housing on the fairgrounds,
- 18 which has yet to happen.
- 19 Regardless, the city is obligated to process the Seaside
- 20 Ridge application because it's a builder's remedy project and
- 21 the necessary project materials were submitted while the
- 22 housing element was out of compliance.
- 23 After your last meeting we sent you a number of public
- 24 records explaining why the city's actions are in error and the

- 1 project application is complete.
- 2 Our team is available today to answer any questions about
- 3 that.
- 4 But you should know that last month the city council
- 5 refused to take up our appeal of the incomplete determination
- 6 made by staff providing us a total of three minutes to address
- 7 the board, to address the council, and we are now forced to
- 8 resort to refiling our litigation against the city to enforce
- 9 its legal obligations.
- 10 It's clear the city is not committed to meeting its
- 11 affordable housing goals.
- 12 The proponents of Seaside Ridge have always been in
- 13 support of affordable housing, including here at the
- 14 fairgrounds if that's your Board's decision.
- 15 But the ENRA should not be used as a way to prolong the
- 16 delivery of affordable housing.
- 17 We ask this Board to consider the city's intentions in
- 18 deciding whether to continue the --
- MS. O'LEARY: Your time is up.
- 20 CHAIR NEJABAT: Thank you.
- 21 JOSEPH SMITH: Good afternoon, President, board members,
- 22 CEO.
- I'm Joseph Smith.
- I'm also here on behalf of Seaside Ridge project that

- 1 could bring 42 lower-income units to the city.
- I need to pivot a little bit in my comments and
- 3 respectfully, Mr. Caplan, I need to disagree.
- 4 The reason that this project is being discussed is
- 5 because the Board has asked, are there any other projects that
- 6 are being considered for the same bucket of units that are
- 7 being proposed here at the fairgrounds.
- 8 And so, when you read the city's housing element, 54
- 9 units need to be sited either on the fairground or vacant
- 10 sites.
- 11 That's a stay law mandate for the vacant site element.
- 12 All the other programs the city talks about may have done
- 13 considerably well at those programs, I must add are in a
- 14 different bucket, that's also true.
- 15 You divide your RHNA in half.
- 16 Half lower income on vacant sites at the fairgrounds as
- 17 well or half on the other sites.
- 18 And so that's why it does matter.
- 19 And that's why this project is being discussed and we
- 20 brought it to you is because you asked for those examples.
- 21 So in other words, if 42 units are built at the Seaside
- 22 Ridge site, that takes pressure off this board from having to
- 23 push so quickly to get 54 units to satisfy the city's housing
- 24 program, at least that other half of it.

- 1 Back to my other comments.
- I just want to note that April 2024, the city entered
- 3 into this RHNA with you.
- 4 There were five years left in the housing cycle.
- 5 The housing cycle ends April 2029.
- 6 There are several key deadlines, including three that are
- 7 noted in that ENRA.
- 8 The last one talks about providing feasible development
- 9 sites, sorry, perspective development sites to the city, which
- 10 has yet to be done.
- 11 That was due last December, the end of the year.
- 12 In lieu, the ENRA was amended as we now understand by
- 13 reading the staff report.
- 14 That amendment kicks those deadlines and removes the
- 15 pressure to actually complete those items outside the housing
- 16 cycle potentially.
- 17 That extension was over 10 months ago and now we have
- 18 three and a half years left in this housing cycle.
- 19 Time keeps ticking.
- 20 Each city sent a letter to the city in December 2024 and
- 21 reminds that city that its milestones need to be implemented
- 22 for the fairgrounds housing program.
- MS. O'LEARY: I'm sorry, sir, your time is up.
- 24 CHAIR NEJABAT: Thanks for your comments.

- 1 CAROL LAZIER: Good afternoon.
- 2 Thank you for giving me a couple of minutes to talk here.
- 3 I'm not an attorney.
- 4 I'm not a developer.
- 5 I'm your neighbor.
- 6 I've lived in San Diego for 30 years and I appreciate the
- 7 value that the fairgrounds brings to the greater community.
- 8 The City of Del Mar has used its relationship with the
- 9 Board to delay and manipulate worthy projects like ours to
- 10 avoid building housing in their city.
- 11 The ENRA agreement continues to stall this much-needed,
- 12 inevitable affordable housing with endless studies, shifting
- 13 timelines, and political maneuvering.
- 14 You have been appointed by the governor to find the
- 15 highest and best use for the fairgrounds.
- You're trusted to serve the public, not just a single
- 17 city.
- 18 You have the power to pause the ENRA, reevaluate the
- 19 agreement, or even end it and hit the reset button if the ENRA
- 20 no longer lines up with your mission statement.
- 21 The broader public is counting on your leadership to make
- 22 sure this property best serves the needs of San Diego County,
- 23 including housing that will actually be built.
- I urge you, Board, to show courage, transparency,

- 1 fairness, and progress for everyone and not just play
- 2 politics.
- 3 Thank you very much.
- 4 CHAIR NEJABAT: Thank you for your comments.
- 5 We have one person on Zoom, Abigail Hawthorne.
- 6 ABIGAIL HAWTHORNE: Hi, can you guys hear me okay?
- 7 CHAIR NEJABAT: Yes.
- 8 ABIGAIL HAWTHORNE: Okay, great.
- 9 My name is Abbie Hawthorne.
- 10 I called in a couple times about the importance of
- 11 affordable housing in your masterplan efforts.
- 12 So, I'm not going to restate all that.
- But I did have a couple of questions related to SB 79 and
- 14 the potential for large landowners like yourself that are next
- 15 to transit.
- 16 This has been a huge undertaking for groups here in the
- 17 region and across the state.
- And I'm curious if you've considered what this means for
- 19 your efforts at large and how you look at it delivering
- 20 transit and with whom, or I'm sorry, housing and with Solana
- 21 Beach Transit Center is just a stone's throw away.
- 22 So I thought maybe there could be some opportunity there.
- I do assume that exclusive means exclusive to Del Mar,
- 24 but was hoping that opportunities with SB 79 might open some

- 1 doors for other cities.
- 2 The director touched on this in her executive report.
- 3 If San Diego were to come forward and wanted to propose a
- 4 partnership for the portion of the fairgrounds that's in their
- 5 city limits, would that be allowed?
- 6 Anyways, it's a pretty new law.
- 7 So, I guess it's just sort of food for thought at this
- 8 point.
- 9 But I was hopeful you would consider all the possible
- 10 solutions especially since your masterplan outreach team is
- 11 still on its road show.
- 12 I'm excited about what could happen at the fairgrounds
- 13 and what it means regionally.
- 14 So thank you for your time.
- 15 CHAIR NEJABAT: Thank you for your comments.
- 16 That concludes public comment.
- 17 Before we entertain a potential motion, I would like to
- 18 ask counsel to clarify what next steps the Board can take on
- 19 this item.
- MR. CAPLAN: Yes.
- 21 Thank you, Chair Nejabat.
- 22 So the item on the agenda for today allows the Board to
- 23 discuss and vote on whether to direct staff to work with the
- 24 City of Del Mar to amend the ENRA.

- 1 So put another way, you are not deciding today to make
- 2 specific amendments to this agreement.
- 3 What you are deciding is whether a majority of the board
- 4 thinks it's appropriate for staff to have discussions with the
- 5 city on perspective amendments that at some point would come
- 6 back to this board for deliberation and discussion.
- 7 The options that the Board has would be to do nothing, as
- 8 Chair Nejabat said at the outset of this meeting.
- 9 If there is no motion and no second, Chair Nejabat would
- 10 move on to the next agenda item.
- 11 That would essentially mean the status quo, right.
- 12 Staff from the District continues to have discussion with
- 13 the city.
- 14 And the studies that are ongoing will continue.
- 15 Or there could be a motion to direct staff to have
- 16 discussions regarding a perspective or several perspective
- 17 amendments to this agreement.
- 18 Which again, wouldn't change things on the ground, it
- 19 would simply allow staff to have those discussions, figure out
- 20 what amendments might be appropriate based on directions from
- 21 the Board and then bring those back at a future meeting for
- 22 the Board to then consider as part of another public meeting.
- But again, keep in mind discussing perspective amendments
- 24 takes two to tango, as they say, right.

- 1 So if this board wants an amendment to an agreement but
- 2 the city has concerns with that, I mean, there'd have to be a
- 3 meeting of the minds.
- 4 But I think you would all learn that at a future meeting
- 5 if that's the direction the Board wants to take and if they
- 6 want to empower staff to start those discussions.
- 7 CHAIR NEJABAT: Okay.
- 8 All right.
- 9 So thank you, Josh.
- 10 With that in mind, does any director have any motion on
- 11 this item?
- 12 DIRECTOR ARABO: I have a motion and question for Josh.
- 13 Are they able during the discussions for the potential
- 14 amendments if we give guiding principles if the majority of
- 15 the Board wants to.
- 16 Is the Board able to pause negotiations while they do
- 17 that based on this wording of this agenda, or no?
- 18 MR. CAPLAN: Two questions there.
- 19 Let me answer the first question first, which is, yes.
- I think if there is a motion and there are certain
- 21 priorities the Board wants staff to consider those discussions
- 22 regarding amendments to this agreement, that would certainly
- 23 be appropriate.
- 24 As to the second question on whether the Board can also

- 1 vote to pause discussions under the ENRA, the short answer is
- 2 no.
- 3 The way the agenda language is framed, that would not be
- 4 an agendized item.
- 5 The ENRA itself would continue to remain in effect
- 6 regardless of whether there is a motion or not on discussion
- 7 related to amendments for the agreement.
- 8 DIRECTOR ARABO: Okay.
- 9 Then my comment, I know we had previous board meetings
- 10 for previous agenda language to be broad enough that the Board
- 11 could actually act and not narrow.
- 12 DIRECTOR GELFAND: Point of information.
- To Director Arabo's point, I believe that we actually
- 14 voted to every month consider this issue and the ability to
- 15 cancel the agreement all together.
- What happened to that?
- 17 Is it gone simply by virtue of the fact it's not
- 18 specifically stated on the agenda or what?
- 19 MR. CAPLAN: All that I can speak to, Director Gelfand, is
- 20 what the Board can or can't do with regards to specific agenda
- 21 language.
- 22 As counsel to the Board, I do not draft the agenda.
- I review agenda if there are specific legal questions.
- But to the extent there's questions about specific agenda

- 1 items, why they are or not on an agenda, that is not a
- 2 question that I can answer.
- 3 DIRECTOR SCHENK: Well, I can tell you as chair, I asked
- 4 that we put it over to the consent calendar as part of the
- 5 consent calendar.
- 6 Because it was a separate item on the calendar each
- 7 month, and to me it seemed like it was not the best use of our
- 8 time to go through this separately.
- 9 And so I think for the last two months or so, maybe up
- 10 until last month it had been on the consent calendar.
- 11 And I think that's where it belongs if we're going to
- 12 continue to have it discussed.
- MR. RIVERA: Director Mead had her hand up.
- 14 DIRECTOR MEAD: Thank you.
- I just want to confirm however that the verbiage that
- 16 reads to amend the exclusive, the ENRA, that is the action
- 17 that we could take so it's either an option to amend it or not
- 18 to amend it or no.
- 19 So there's three options: amend, don't amend, or no
- 20 action at all.
- 21 Am I understanding that correctly, Josh?
- MR. CAPLAN: Director Mead, not entirely.
- 23 DIRECTOR MEAD: Okay.
- MR. CAPLAN: The Board can't today vote to amend the ENRA.

- 1 What the Board can do today is they can vote to authorize
- 2 staff to have discussions with the city regarding potential
- 3 amendments.
- 4 DIRECTOR MEAD: Okay, and then bring that back to us?
- 5 MR. CAPLAN: Yeah, that is correct.
- 6 And the second option is the Board can do nothing.
- 7 The ENRA as it would no matter whether there is a motion
- 8 or not, right, the ENRA is in place.
- 9 District staff will continue to work with the City of Del
- 10 Mar in implementing the ENRA.
- 11 And so, but the Board could, so if the Board does
- 12 nothing, the process continues.
- 13 DIRECTOR MEAD: Okay.
- MR. CAPLAN: And then the District or Carlene and her team
- 15 will bring updates to the Board periodically as those studies
- 16 are completed as she mentioned in her staff report today.
- 17 DIRECTOR MEAD: Thank you.
- 18 So then I guess I really appreciate that clarification.
- 19 So then I still think there may be a third option, which
- 20 is we direct them to amend with direction that we provide.
- 21 So the amend isn't broad, we specifically say amend in
- 22 this manner.
- MR. CAPLAN: Yes, you could vote to direct staff.
- Yeah, you could vote to direct staff to work with the

- 1 City of Del Mar to make specific amendments and apply those
- 2 amendments.
- 3 DIRECTOR MEAD: Okay.
- 4 MR. CAPLAN: And you could identify those amendments, and
- 5 that after discussions between District staff and the city,
- 6 those would then come back to the Board at another public
- 7 meeting for deliberation and another vote on actually
- 8 implementing those changes to the agreement.
- 9 DIRECTOR MEAD: Thank you for that clarification.
- 10 DIRECTOR ARABO: Okay, so I'll do a motion if it's time to
- 11 do it.
- MS. MOORE: I just want to, I was just speaking with Chair
- 13 Nejabat on this.
- Just to offer some insight into, there seems to be
- 15 perhaps some confusion in terms of the agenda item.
- 16 This was a specific request that was received to have
- 17 this item on this agenda.
- 18 I worked with Chair Nejabat and counsel on for having on
- 19 this.
- 20 That was before that specific request came in, there was
- 21 discussion with the executive committee with regard to the
- 22 agenda.
- I just want to clarify that when it comes to the actual
- 24 agenda while it seems like there's some assumption that is

- 1 being created by staff, it is not.
- 2 It is a collective process where we wind up with these
- 3 agenda items.
- 4 So I just like to have them on the record.
- 5 Thank you.
- 6 DIRECTOR GELFAND: So somebody who is unnamed requested
- 7 that the agenda item be structured this way as opposed to the
- 8 way it has been in the past?
- 9 MS. MOORE: There was a specific request to have on the
- 10 agenda today this discussion for to direct staff, for
- 11 directing and potential amendment.
- 12 As staff have no other information to share with you on
- 13 that but this was a specific request.
- And so and with that because previously and that's why
- 15 under my executive report is the monthly updates of what is
- 16 transpiring between these with regard to staff and the City of
- 17 Del Mar staff.
- 18 Because much of the work under the ENRA is staff to staff
- 19 work.
- 20 DIRECTOR ARABO: Yeah.
- One request I would do in the public is any agenda item
- 22 if a board member would, it should be broad, broad enough.
- Because if a board member brings up an agenda item, it's
- 24 the idea of it but it should be a broad action item.

- 1 So at that point, it's hard to get everyone meets, gets
- 2 notice to the public, everyone is investing their time and
- 3 then we have our counsel say no, this is very narrow the way
- 4 it's worded.
- 5 And I just feel like it's good to get information from
- 6 the Board as far as the idea, but I encourage the broadness of
- 7 it so that way they can act on it.
- 8 VICE CHAIR BARKETT: I'm going to say something.
- 9 I think the facts have changed a little bit since we all
- 10 did this.
- 11 And so I see where a board member might want to revisit
- 12 this.
- 13 And we're just revisiting it.
- It's not saying this is exactly what we want.
- 15 And I think we have to look at it because facts have
- 16 changed and that's all it's saying.
- 17 It's saying it back to staff to look, every board member
- 18 will get their chance to say something at the next meeting or
- 19 whenever the following meeting after that in regards to it.
- 20 So it's, you know, but the facts have changed.
- 21 And we're learning a lot more than we knew before.
- 22 DIRECTOR ARABO: Okay.
- I would like to make a motion to direct staff to amend
- 24 the ENRA between the District and the City of Del Mar with

- 1 some guiding principles.
- 2 Should I say the guiding principles in the motion?
- 3 The guiding principles is that amendments should be in
- 4 total alignment with SB 79, which was a recent law that our
- 5 governor signed into law.
- 6 It should protect the state interests and reflect
- 7 California housing vision, and it should add qualified
- 8 partners and require milestones and actions come to the full
- 9 board for review, not in the hands of staff.
- 10 And it also should -- I think that summarizes it.
- 11 Oh, it should drop the exclusive and open it to other
- 12 cities.
- 13 So basically amend the ENRA.
- 14 I think direct staff to negotiate amendment the ENRA
- 15 continuing the negotiation but removing the exclusivity that
- 16 the District would have to allow the District and explain
- 17 discussion if it gets there, why, and align with SB 79 and
- 18 bring the milestones back to the Board.
- 19 Right now no other city in the region can contact the
- 20 District for housing.
- 21 Only --
- DIRECTOR ARABO: SB 79.
- I mean, we've had a groundbreaking, I don't know if this

- 1 is a good time, Josh, it's a good time to talk about it.
- 2 Okay.
- 3 Of the reasoning.
- 4 California leads and we have a tremendous governor.
- 5 Two or three days ago, SB 79 was signed into a law and
- 6 now it's the law of the land encouraging state facilities to
- 7 do more housing.
- 8 I think as a state agency with 300 acres, we have a
- 9 tremendous role we could play in putting affordable housing on
- 10 the District.
- But I feel like we cannot do it if we're exclusive with
- 12 any city.
- I want to open it up to any city in the county that wants
- 14 to talk to us to do housing, let's build affordable housing on
- 15 the District but let's talk to everyone.
- 16 And that's the basis.
- 17 And also that will put pressure on Del Mar to say let's
- 18 really do this.
- 19 Because I feel the worst thing that can happen is that we
- 20 do the study and then we don't do the housing.
- 21 That is the worst case scenario.
- 22 DIRECTOR SCHENK: I appreciate the explanation.
- DIRECTOR ARABO: 2013 we entered into talks, 12 years
- 24 later there's not one affordable house on the District.

- 1 And I think we have a big role to play.
- I think we need align with our governor and the state and
- 3 provide affordable units.
- I think with this agreement, it's so one sided it
- 5 handicaps us.
- 6 It doesn't allow us to talk to anyone else.
- 7 And that's the spirit of the amendment.
- 8 MR. CAPLAN: The only thing I would add is this agreement,
- 9 the exclusivity language, which I'll defer to the Board to
- 10 vote and direct staff to have discussions on the amendments.
- 11 The agreement provide the exclusivity is applicable only
- 12 to the portions of the fairgrounds that are within the City of
- 13 Del Mar.
- 14 And so what that practically means is this ENRA would not
- 15 prevent you all from having discussions with the City of San
- 16 Diego on developing Horsepark or parts of Horsepark for
- 17 affordable housing.
- 18 You all remain able to have those discussions under the
- 19 existing agreement.
- 20 But certainly, Director Arabo's other point, is you all
- 21 are having discussions with other cities on developing
- 22 affordable housing on your property that falls within the City
- 23 of Del Mar's jurisdiction, I defer to the Board on that.
- 24 DIRECTOR GELFAND: You are essentially saying that the

- 1 exclusivity provision in the ENRA has no effect, right?
- 2 MR. CAPLAN: No, it does.
- 3 What I'm saying is that if you look at the agreement
- 4 itself it doesn't define property as the entire fairgrounds
- 5 property.
- 6 It defines property as District property located within
- 7 the City of Del Mar.
- 8 And so you all own property that falls within the City of
- 9 Del Mar and your Horsepark property.
- 10 The exclusivity piece here, all that really says is that
- 11 22<sup>nd</sup> DAA during the first stage of the ENRA negotiations,
- 12 negotiate only with us on the development of affordable
- 13 housing within the City of Del Mar's limits.
- 14 And then further on in the ENRA.
- 15 So that means you can't go to the City of San Diego or
- 16 the City of Escondido, or the City of Chula Vista and work
- 17 with them to build affordable housing on the part of the
- 18 fairgrounds that falls within the City of Del Mar.
- 19 That's what the exclusivity piece it talking about in
- 20 this agreement.
- 21 DIRECTOR GELFAND: Okay, so for all intents and purposes
- 22 it is kind a moot provision but I -- it's okay.
- 23 >> [off mic]
- VICE CHAIR BARKETT: But it's Del Mar property.

- 1 So we wouldn't have that, whereas we would have the
- 2 ability to negotiate something or look into it with Horsepark
- 3 like you said.
- 4 Or on the other side of this, which is the golf and the
- 5 mobile homes, that whole section, which is City of San Diego.
- 6 DIRECTOR GELFAND: What I'm saying is let's say staff does
- 7 negotiate with Del Mar and they refuse to remove the
- 8 exclusivity provision, we can still go talk to the City of San
- 9 Diego or any other city about DAA property outside of the City
- 10 of Del Mar.
- 11 [multiple speakers]
- 12 VICE CHAIR BARKETT: -- in this agreement, that should be
- 13 one of the clarifications because --
- 14 DIRECTOR GELFAND: That's a good idea.
- 15 VICE CHAIR BARKETT: It doesn't come out.
- And that's one of the things we're thinking about.
- 17 Not only that, you know, good faith and fair dealing,
- 18 okay.
- 19 We're all under it, both parties.
- 20 And you know, it should be very clear what this agreement
- 21 is about.
- I have to say I was a little surprised with the M.O.U.
- We're not going to get into that because that's not on
- 24 the agenda.

- 1 You know, there are certain things, new facts that we
- 2 have seen now as directors in this recent packet.
- 3 DIRECTOR ARABO: Yeah, I echo Vice President Barkett's
- 4 comments.
- I mean, the M.O.U. was a total surprise.
- 6 I feel like the Board in this housing discussion is in
- 7 the dark.
- 8 I think that we all deserve transparency.
- 9 And I think we all should be going towards the path to
- 10 building affordable units on state land and that's what SB 79
- 11 is.
- 12 I know there's a potential exemption with Coaster and
- 13 Amtrak but the spirit of the law is there's a housing crisis,
- 14 we have 300 acres, we should build a bunch of affordable
- 15 units.
- And make it clear to ENRA in writing that we're going to
- 17 also approach the City of San Diego, develop Horsepark.
- 18 There was a tremendous opportunity for us to align with
- 19 our governor, with the state in a time of crisis.
- 20 And I think we could show real leadership by doing it and
- 21 stop talking about it.
- 22 And that's why the amendments one of them is aligned
- 23 completely with SB 79.
- 24 And also bring every milestone to the Board so that way

- 1 we don't get an email the night before a meeting of an M.O.U.
- 2 that was signed in May of this year.
- 3 VICE CHAIR BARKETT: Well, there's four cities that were
- 4 excluded.
- 5 We have Del Mar, Solana Beach, Carlsbad, and Encinitas.
- 6 So if it had gone the other way where they were included,
- 7 it would actually be a better fit to be honest.
- 8 But they were excluded so --
- 9 DIRECTOR GELFAND: Where is that?
- 10 VICE CHAIR BARKETT: That's in the new law.
- 11 DIRECTOR GELFAND: Oh, in the new law.
- 12 DIRECTOR ARABO: Yeah, because there's an exemption, I
- 13 believe, for Coaster and Amtrak.
- But the spirit is use state land, expedite, build
- 15 affordable units.
- 16 We have over 200 acres and we're a state agency.
- 17 We should lead and follow our governor and align with his
- 18 vision on housing.
- 19 That's my opinion.
- 20 DIRECTOR GELFAND: So I have a procedural question.
- I mean, we don't have a second yet.
- I don't know where we are in terms of our discussions.
- 23 From a procedural standpoint, if this motion passes,
- 24 would it prevent us next month when we next meet if it

- 1 happened to be on the agenda would it prevent us from saying
- 2 we don't want housing on the property, which is in the City of
- 3 Del Mar?
- 4 VICE CHAIR BARKETT: I think there's not enough
- 5 information.
- 6 We're still in the process.
- 7 DIRECTOR ARABO: You know, I think the idea is, the intent
- 8 is also to either through an RFP or through staff or through a
- 9 developer that wants to put affordable units on the District
- 10 land.
- 11 Us as the fairgrounds we could do our own units with the
- 12 city.
- I think we should explore everything.
- 14 And that's another point to Josh's.
- 15 If we want to do it, I know it's in the City of Del Mar,
- 16 but how about if the District wants to put affordable housing
- 17 units?
- 18 DIRECTOR GELFAND: No, I agree.
- 19 What I'm saying, I mean, from my standpoint just looking
- 20 through the lens of master planning, I don't personally think
- 21 that the main fairground campus, which is in the City of Del
- 22 Mar is the right place to put housing.
- I think the City of San Diego property, whether it's
- 24 right across Jimmy Durante or Horsepark, I think either of

- 1 those locations would make a lot more sense from a master
- planning standpoint.
- 3 So I'm just asking if this motion passes, does it, I
- 4 mean, does it prevent us at some point in the future from just
- 5 telling the City of Del Mar we just don't want to accommodate
- 6 you on the Del Mar property?
- 7 DIRECTOR ARABO: Yeah, I don't think it does that because
- 8 right now it's a study.
- 9 But what I wanted to bring in front of the Board is I
- 10 think we should really pursue affordable housing on our
- 11 property.
- 12 And one way of doing that to be very clear is in the
- 13 agreement we're also going to be talking to the City of San
- 14 Diego.
- We have to make it crystal clear so it doesn't end up
- 16 being litigated.
- 17 You know, we said this, staff said this and the Board
- 18 said this.
- 19 We have to be very, very clear.
- This is our expectation.
- We want to do it.
- 22 And this is -- we don't want to be inhibited.
- 23 DIRECTOR SCHENK: I have a procedural question to our
- 24 counsel.

- 1 I'm grateful for the motion that's being proposed.
- 2 Is that considered on our agenda for today to be able to
- 3 add that particular motion?
- 4 MR. CAPLAN: Yeah, I think it's appropriate for Director
- 5 Arabo, essentially he made a motion to authorize staff to
- 6 discuss amendments to the ENRA, including the guiding
- 7 principles that would be important to the majority of the
- 8 Board if the motion is approved.
- 9 DIRECTOR SCHENK: I'm glad to hear that.
- I just wanted to make sure that we're not going sideways.
- 11 VICE CHAIR BARKETT: Well, and if I could add to that.
- 12 The guiding principles, one thing that I was concerned
- 13 with when I saw the packet, especially the letter last evening
- 14 is the timeline.
- 15 I think it is off now.
- I didn't have enough time because I didn't see it until
- 17 9:00 at night.
- 18 It would have been great to have more notice but we have
- 19 to look back.
- I know our staff is more than qualified to look at that
- 21 and look at the timeline and tell us if there is an issue
- 22 there.
- 23 CHAIR NEJABAT: Director Mead, I know you've had your hand
- 24 up for a while.

- 1 Sorry.
- DIRECTOR MEAD: No problem, thank you.
- 3 That's what happens when you don't get to be there in
- 4 person, you wait.
- 5 No problem, Mr. Chair.
- I just want to clarify a couple of things, especially
- 7 about the motion that is on the table.
- 8 First, I agree with Director Gelfand that this should
- 9 really be a part of our master planning process.
- 10 And I don't know that we are in a place now where we want
- 11 to enter into negotiations with anyone about housing on the
- 12 fairgrounds.
- Director Arabo, unless I'm incorrect, we sit in San Diego
- 14 and Del Mar, we couldn't really help any other city meet their
- 15 housing requirement because we're not in their city.
- 16 So we couldn't help Escondido meet their Escondido
- 17 requirement.
- 18 It leaves us Del Mar and the City of San Diego, if I
- 19 understand the way the housing requirements work.
- I am looking at this and thinking that we needed an
- 21 amendment that provides us information since this is an
- 22 exclusive negotiating agreement with Del Mar, with us only.
- 23 That what we really want to do is to tighten up this
- 24 amendment to ensure that the City of Del Mar is providing us

- 1 with updates on what other options they are considering should
- 2 the fairgrounds make a determination that we are not
- 3 interested based on our masterplan in putting housing in the
- 4 Del Mar section of the fairgrounds property.
- 5 So to tighten up that language specific to the
- 6 discussions with Del Mar.
- 7 Was that clear as mud?
- 8 VICE CHAIR BARKETT: Are you done, Kathlyn?
- 9 DIRECTOR MEAD: Yes.
- 10 VICE CHAIR BARKETT: Okay.
- 11 Well, I just want to, you know, honestly, I agree with
- 12 what you saying.
- 13 The only problem is we really don't have a right to tell
- 14 Del Mar, you know, we expect they are doing that.
- 15 That's inherent in this, that they are going out and
- 16 talking to other, you know, cities and seeing if something can
- 17 be done with other people.
- 18 But that really isn't our business to get involved in.
- 19 Who they are talking to, what they are talking to them
- 20 about.
- 21 You know, it's just inherent and good faith and fair
- 22 dealing that they are doing that.
- I'm more concerned about us.
- That we need to have the ability to go and right now

- 1 we're, you know, I mean when people read this, they said boy
- 2 you are really, you know, making yourself, meaning the 22nd
- 3 DAA, you know, cramping your ability to talk to other cities.
- 4 And I thought that was interesting with other cities.
- 5 And that's how this is garnered.
- I think we have to go back and like you said, amend the
- 7 language so we're very clear.
- 8 But as far as the City of Del Mar, I don't think we have
- 9 any control in that aspect.
- 10 And we should move forward with our plan, our vision for
- 11 what this place is going to look like and be.
- 12 And if it works out through staffs on both sides, that
- 13 yeah, we can put some units, then it's going to work out.
- But right now, we don't want to be tied down.
- 15 I do think there's a problem with the time table now when
- 16 I look at the M.O.U. and I think we just need to go back.
- 17 You know the M.O.U. is a very important document.
- 18 It's not going to steer you wrong.
- 20 And we just got this last night after business hours.
- 21 We really need to go back and look at everything.
- 22 MS. MOORE: If I can just provide a little bit of
- 23 clarification here.
- So there has been some comments about not having

- 1 information.
- 2 There isn't information yet to share with you and there
- 3 is no decision before this board as of right now related to
- 4 affordable housing.
- 5 The M.O.U. is a document that funds those studies to
- 6 bring that information back to you.
- 7 It's for being able to receive the HAP grant funds.
- 8 And while the document may be new, we have previously
- 9 talked about the HAP grants in the updates and reports.
- 10 But that's what the M.O.U. does.
- 11 The amendment that was done to the ENRA, and I hear you
- 12 in terms of the timeline.
- 13 And what that did was move that timeline out.
- 14 So happy to go back and relook at those dates.
- 15 But we are currently under contract to get you that
- 16 information for your decision-making process.
- 17 And that is funded through the HAP grant, which comes
- 18 through the ENRA as a current.
- 19 So even the consideration of putting things on pause
- 20 could just put us potentially, it doesn't sound like that's
- 21 where we're going but could potentially put us in a situation
- 22 of ours at the  $22^{nd}$  DAA contractual requirements for those
- 23 studies that we have and not knowing whether or not that
- 24 funding it could put the funding source for those studies at

- 1 risk.
- 2 But I just want to be very clear to this board, you will
- 3 absolutely be receiving the information from those studies as
- 4 we get it.
- 5 And we anticipate that -- and we anticipate based on the
- 6 timeline of that information coming in the first quarter of
- 7 the year because it does take time to complete some of those.
- 8 Please know, because you are not making a decision today
- 9 on affordable housing.
- 10 And what we have is a timeline that allows even further
- 11 time for it, there is no urgency on our part to make that
- 12 decision.
- 13 VICE CHAIR BARKETT: I'm sorry, just one thing.
- We are behind on our quarterly reports now.
- You know, we missed two.
- 16 Another one was due on September 30th according to the
- 17 M.O.U.
- MS. MOORE: That, I'm sorry, that is the reports we have
- 19 to provide for the HAP grant funding.
- The M.O.U. is specific to the grant of funds and we have
- 21 met those thresholds.
- 22 Because that is to the city of, I'm sorry, the City of
- 23 Del Mar, for them to SANDAG and HCD --
- 24 VICE CHAIR BARKETT: It says the city will provide the

- 1 District with a copy.
- MS. MOORE: Oh, I'm sorry then.
- 3 We have met providing our information, so we'll go back
- 4 and double check some of those.
- 5 And I appreciate that in terms of when you are talking
- 6 about the timeline on the M.O.U.?
- 7 VICE CHAIR BARKETT: Right.
- 8 MS. MOORE: I thought previously you were speaking to the
- 9 ENRA.
- 10 VICE CHAIR BARKETT: No.
- 11 Thank you.
- 12 My fault.
- 13 MR. CAPLAN: And I'm just going to try to refocus back
- 14 Director Arabo's motion.
- 15 Refocus from the language of the M.O.U. regarding
- 16 reimbursable cost for and expenses related to reports back to
- 17 the motion that Director Arabo made regarding directing staff
- 18 to discuss the amendments on the ENRA with the city.
- 19 CHAIR NEJABAT: For clarity purposes.
- DIRECTOR ARABO: Yeah.
- 21 They could read it back, the three guiding principles.
- MS. MOORE: We don't have a transcriptionist.
- 24 So we're all trying to make notes.

- 1 I think what might be helpful is if you could please
- 2 restate the motion as you were reading it from your notes.
- 3 Thank you.
- 4 DIRECTOR ARABO: I would direct staff to amend the ENRA
- 5 agreement with the City of Del Mar.
- 6 And to make sure that it's in full alignment with Senate
- 7 Bill 79, which is now the law of the land, protect state
- 8 interests, reflect California housing vision, and all future
- 9 milestones and actions have to have full Board review and
- 10 approval.
- 11 So taking the negotiations through every milestone since
- 12 the public deserves to know in an open setting where are the
- 13 negotiations, how are they going, and where are we going so we
- 14 don't stall the time line.
- 16 DIRECTOR ARABO: I'm happy to -- and also the removing
- 17 exclusivity, even though it's -- so it's very clear.
- 18 And I hope the Board at another meeting does talk to the
- 19 City of San Diego and we do put affordable housing units on
- 20 the District land.
- 21 SB 79 is an amazing law the governor signed.
- 22 I think it's a real opportunity for us to align with his
- 23 vision.
- 24 CHAIR NEJABAT: Motion by Director Arabo, do we have a

- 1 second?
- MS. DeBerry: Second.
- 3 CHAIR NEJABAT: Second, Director DeBerry.
- 4 Any further discussion from the Board?
- 5 DIRECTOR MEAD: I have a clarifying question.
- 6 If we, I thought I understood earlier that we could not
- 7 cancel the agreement but if we make a requirement of agreement
- 8 that it is non-exclusive, then isn't that canceling the
- 9 Exclusive Negotiating Rights Agreement?
- 10 DIRECTOR ARABO: No, from my perspective we're amending it
- 11 to allow the fairgrounds to talk to any developer who wants to
- 12 put any affordable units on the fairgrounds.
- 13 DIRECTOR MEAD: So that is no longer an Exclusive
- 14 Negotiating Rights Agreement, which in essence we give
- 15 direction -- [multiple speakers]
- 16 DIRECTOR ARABO: [off mic] We do put their units on our
- 17 land.
- 18 VICE CHAIR BARKETT: Well, I think in light of the law,
- 19 but okay, I want to ask our counsel.
- Sorry.
- 21 By implementing this motion with guiding principles, is
- that outside the purview?
- MR. CAPLAN: No, so Director Arabo's motion is essentially
- 24 authorizing, I don't want to speak for you, Director Arabo.

- 1 But what I hear from our motion is that you are
- 2 authorizing staff to have discussions with the city on these
- 3 perspective, I call them perspective amendments because these
- 4 perspective amendments will have to come back to this board.
- 5 DIRECTOR MEADE: Okay.
- 6 MR. CAPLAN: Have to go to the city council for approval.
- 7 But it sounds like what you are directing staff to do
- 8 through your motion is to discuss potential amendments based
- 9 on your guiding principles.
- 10 Those amendments will then have to come back.
- 11 If there is a meeting of the minds between the District
- 12 and the City of Del Mar, even if there's not, staff will have
- 13 to bring that back to the Board and we would provide some
- 14 explanation to whether specific amendments are being provided
- 15 for the Board to consider to approve and maybe why other
- 16 amendments are not part of that.
- 17 Maybe there was a meeting of the minds or not agreement
- 18 with the other party.
- 19 VICE CHAIR BARKETT: Exactly.
- Okay.
- 21 DIRECTOR MEAD: Thank you.
- I better understand that.
- Thanks.
- 24 DIRECTOR SCHENK: Director Arabo, it sounds like this

- 1 motion and second would allow us to do is not be limited to
- 2 conversations with any city or municipality.
- 3 DIRECTOR ARABO: Correct.
- 4 DIRECTOR SCHENK: We're not limited to municipalities,
- 5 we're now expanding that scope to private industry.
- 6 DIRECTOR ARABO: Exactly.
- 7 Yeah, that is the point of it, what Director Schenk
- 8 exactly made.
- 9 It's expanding the potential of doing more development
- 10 for affordable housing with anyone on this district.
- 11 DIRECTOR SCHENK: Beyond municipality.
- 12 DIRECTOR ARABO: Beyond cities.
- 13 If the fairgrounds, if the Board beyond cities as a
- 14 welcoming.
- 15 I think this comes from the effect of SB 79 the governor
- 16 signed.
- 17 I think it's very important as a state agency that we
- 18 align with his vision on housing.
- 19 It is a great vision, I think we should follow it.
- 20 And this is our opportunity.
- We just signed into law.
- 22 And I've got to say, I was disappointed the City of Del
- 23 Mar was against it.
- They opposed it.

- 1 Which is disheartening.
- 2 They sent a letter against SB 79 but now it's the law of
- 3 the land.
- 4 And I think it's important we align this negotiation
- 5 agreement has to fully align with it.
- 6 And I would like to ask Chair Nejabat if depending on the
- 7 next agenda item, hopefully we could put a pause just on the
- 8 agenda to let the city know we're serious about working
- 9 together but buy more time.
- 10 VICE CHAIR BARKETT: There I think we should be careful
- 11 because like we said, it pauses studies, the studies that are
- 12 currently going on.
- 13 DIRECTOR ARABO: Right.
- No, I don't want to pause that.
- 15 VICE CHAIR BARKETT: We don't want to do that.
- 16 Yeah.
- 17 You could still -- why even pause it, they should be
- 18 talking.
- 19 That's what we want.
- 20 DIRECTOR ARABO: But perspective is how about if the City
- 21 of Del Mar says we don't want to align with SB 79.
- VICE CHAIR BARKETT: Well, they will come back and tell us
- 23 that.
- But unfortunately, we're in an agreement right now that

- 1 it takes two to tango, as they said before.
- DIRECTOR ARABO: I'm okay with that.
- 3 VICE CHAIR BARKETT: And we have to let them speak on
- 4 this, the city.
- 5 DIRECTOR DeBERRY: And the studies have value.
- 6 VICE CHAIR BARKETT: They do.
- 7 MS. MOORE: These studies have value beyond, of that's
- 8 your question, Director DeBerry, beyond the affordable
- 9 housing.
- DIRECTOR ARABO: But hopefully, we see units.
- 11 We've been talking about this since 2013 based on the
- 12 paper.
- 13 DIRECTOR SCHENK: Oh, let me tell you -- [multiple
- 14 speakers] -- 12 years.
- 15 Even before that there was discussions about putting up a
- 16 hotel on the property.
- 17 DIRECTOR ARABO: Hopefully, we get shovels in the dirt and
- 18 get some affordable units on.
- 19 DIRECTOR MEAD: That said, Director Arabo, this board has
- 20 not heard any recommendations for housing or taken any action
- 21 that would support that statement by the Board entirely.
- I just want to clarify that.
- I know your position and I know that legislation that has
- 24 passed.

- 1 But I think what you are talking about needs to be
- 2 agendized and discussed and voted upon before we talk broadly
- 3 about housing on the fairgrounds.
- 4 DIRECTOR ARABO: Yeah.
- I agree.
- 6 CHAIR NEJABAT: Any other comments?
- 7 DIRECTOR GELFAND: I'm a little confused about what this
- 8 actually accomplishes.
- 9 That's one issue I want to talk about.
- 10 And the other is a clarification.
- 11 Just taking a quick look at the agreement, the ENRA.
- 12 It doesn't really say in there that we can cancel it at
- 13 any time.
- 14 There's a 24-month period and then there's renewals.
- 15 We had it on our agenda in the past to consider whether
- 16 or not to stop discussions with the City of Del Mar.
- 17 It seems like that's been inconsistent with the agreement
- 18 itself because it doesn't have a provision for ceasing
- 19 negotiations or discussions or ending the agreement, which is
- 20 a little odd but we do have this window of April of 2020 -
- 21 VICE CHAIR BARKETT: '27.
- DIRECTOR GELFAND: I think it's '26 because it's 24 months
- 23 from April of 2024.
- 24 But putting that aside, because -- [multiple speakers] --

- 1 VICE CHAIR BARKETT: 2027.
- 2 DIRECTOR GELFAND: It does impact the potential agenda
- 3 item next month of whether we consider ceasing the ENRA.
- 4 But the motion itself there's nothing about the ENRA that
- 5 I could see that prevents us with our entire property, not
- 6 just the City of Del Mar property, but with the entire
- 7 property from complying with SB 79.
- 8 And there's nothing in the agreement that prevents us
- 9 from a full board review.
- 10 And so and the exclusivity issue seems to be moot to me
- 11 anyway.
- 12 So I'm not opposed to the motion, I just don't see what
- 13 it accomplishes.
- 14 DIRECTOR ARABO: Well, there's the, you hammer out the
- 15 details, the cleaner you are in the agreement, the better.
- 16 I don't think it's a moot motion, but in the event the
- 17 City of Del Mar does, then it's easy, we just keep going.
- I think they should be very clear that we should align
- 19 fully with SB 79 and the spirit of it as far as moving forward
- 20 as fast as we can.
- 21 DIRECTOR SCHENK: Director Arabo, if I may also respond.
- I think what it says here is that whether we're the ones
- 23 putting up those units or somebody on behalf of the City of
- 24 Del Mar, it's to their benefit if we put up the units within

- 1 the City of Del Mar but it will be on our timeline and at our
- 2 discretion.
- 4 DIRECTOR ARABO: Yeah.
- 5 We don't want, for me, to drag this on and then all of a
- 6 sudden it doesn't happen.
- 7 I'm hoping we get units.
- 8 Like I said, I looked at the notes, 2013 we've been
- 9 talking about it on the record.
- Nothing has been done.
- And now we've missed milestones.
- We've missed deadlines.
- I think we should sprint to the finish line.
- 14 And but a part of that also, the amendment is it brings
- 15 milestones back to the Board.
- 16 Like for example, an M.O.U. was signed in May.
- 17 We've had meetings since May but we don't know about the
- 18 M.O.U. until last night, via email.
- 19 I think it's important the Board and the public know
- 20 every single milestone and every step, not just when someone
- 21 asks about it.
- Because it's such a big thing that the region needs.
- 23 DIRECTOR GELFAND: I do think the ongoing process is good
- 24 in that it's providing the HAP money and the studies, which

- 1 are beneficial to us.
- VICE CHAIR BARKETT: You know I don't understand why the
- 3 city sent that out last night.
- 4 I'm a little confused.
- 5 MR. CAPLAN: I think we should try to focus.
- 6 VICE CHAIR BARKETT: Right.
- 7 But I'm just saying -
- 8 MR. CAPLAN: But there's a motion on the table.
- 9 I don't know if there is yet a second.
- 10 CHAIR NEJABAT: There is.
- MR. CAPLAN: There is.
- 12 So if there was discussion specifically on Director
- 13 Arabo's motion and second.
- 14 But again, I think we should postpone any discussion on
- 15 the M.O.U. for a future meeting when it can be properly
- 16 agendized for a full discussion.
- 17 CHAIR NEJABAT: Any other further discussion on this
- 18 motion?
- 19 No?
- Okay, so with that being said, we'll take a roll.
- MS. O'LEARY: Okay.
- 22 Chair Nejabat.
- 23 CHAIR NEJABAT: Aye.
- MS. O'LEARY: Vice Chair Barkett.

- 1 VICE CHAIR BARKETT: Aye.
- MS. O'LEARY: Director Arabo.
- 3 DIRECTOR ARABO: Aye.
- 4 MS. O'LEARY: Director DeBerry.
- 5 DIRECTOR DeBERRY: Aye.
- 6 MS. O'LEARY: Director Gelfand.
- 7 DIRECTOR GELFAND: Aye.
- 8 MS. O'LEARY: Director Mead.
- 9 DIRECTOR MEAD: Aye.
- MS. O'LEARY: Director Schenk.
- 11 DIRECTOR SCHENK: Aye.
- 12 CHAIR NEJABAT: All right, motion carries.
- Moving onto item 9.
- 14 Matters of information.
- 15 Before we adjourn, I would like to note that you can find
- 16 matters of information beginning on page 58 of your packet.
- 17 That includes the new committee assignments and all
- 18 contracts executed by the CEO's delegation of authority.
- 19 And lastly, before we adjourn today's board meeting, I
- 20 would like to take this opportunity to acknowledge Donna
- 21 O'Leary for her years of service to the Board.
- 22 You've been nothing but great since I joined and thank
- 23 you for all the help and last-minute requests and everything
- 24 you've done for this organization in general.

- 1 She's retiring next month and this is her last meeting.
- 2 How about a round of applause.
- 3 VICE CHAIR BARKETT: Thank you so much, Donna.
- 4 DIRECTOR GELFAND: On the committee assignments I got a
- 5 question.
- 6 CHAIR NEJABAT: Sure.
- 7 DIRECTOR GELFAND: So I've been assigned to a committee
- 8 that is responsible for under Master Site Planning,
- 9 Environmental Stewardship Committee.
- 10 It seems to me, and then there's a new committee, I think
- 11 it's new, the liaison to Technical Advisory Coalition.
- 12 CHAIR NEJABAT: That's been there.
- 13 DIRECTOR GELFAND: Has it been there?
- 14 CHAIR NEJABAT: Yeah.
- 15 DIRECTOR GELFAND: Okay, so the Environmental Stewardship
- 16 Committee I think is going to want to talk to the TAC, the
- 17 Technical Advisory Committee and work with them.
- 18 How in a Bagley-Keene context can the Environmental
- 19 Stewardship Committee do that?
- MR. CAPLAN: No, they can have those discussions in this
- 21 meeting on a monthly basis.
- 22 MS. MOORE: And are you referring wanting to talk to the -
- 23 because there is the Technical Advisory Coalition, which is
- 24 the group of pro bono people who are working.

- 1 There is a liaison committee to that coalition.
- DIRECTOR GELFAND: Right.
- 3 I'm talking about the coalition.
- 4 Caan we talk to the coalition members, not the committee
- 5 members, the coalition members.
- 6 So for example, in that coalition of technical advisors,
- 7 there are people who are experts in wetland development and
- 8 maintenance.
- 9 That's really relevant to the --
- 10 MR. CAPLAN: Yeah, I think the short answer is yes, you
- 11 can talk to the same set of experts that another committee is
- 12 talking to but you can't form consensus.
- 13 Those experts certainly should just be cautioned not to
- 14 be sharing the information they're discussing with one
- 15 committee with another.
- And I will defer to Carlene and her team to ensure those
- 17 quardrails are in place.
- 18 But yes, you all can talk to the same group of community-
- 19 based experts to answer technical questions to help the
- 20 committee do it.
- 21 DIRECTOR GELFAND: Good.
- Thank you.
- 23 DIRECTOR ARABO: You know, to your point, to Director
- 24 Gelfand's point, it would be, Josh, is the TAC able to come to

- 1 the full board and we talk and meet with them on a publicly
- 2 noticed meeting?
- 3 MR. CAPLAN: Any member of the public is allowed to come
- 4 to any public meeting and share public comment.
- 5 DIRECTOR ARABO: Are we able to invite them for a
- 6 presentation?
- 7 MR. CAPLAN: I defer to the president -- [multiple
- 8 speakers]
- 9 CHAIR NEJABAT: I don't see why not.
- MS. MOORE: And we are.
- Just as a reminder and as part of our quarterly update we
- 12 have spoken to this.
- 13 Right now the Technical Advisory Coalition is kind of
- 14 doing their work.
- 15 So similar to the feasibility studies that are being
- 16 done, they are doing their work and they will be coming to
- 17 present or representatives ultimately will be coming to
- 18 present to this board.
- 19 DIRECTOR ARABO: I'm asking if they can come not when they
- 20 are finished, throughout the process in case we can say almost
- 21 like a work in progress, we have this so far.
- I think that way they could get some input and we could
- 23 also learn a lot from them.
- 24 As opposed to a fully baked, this is it.

- 1 DIRECTOR GELFAND: Right.
- 2 And I have a related question also to all of this.
- 3 There is the Technical Advisory Coalition, which is this
- 4 group of experts that are working pro bono for us.
- 5 I have no involvement in the establishment of who is on
- 6 that coalition.
- 7 If I had, I would have suggested that there were
- 8 financial experts on that Technical Advisory Coalition to help
- 9 advise us in what your committee is going to be doing, Mark,
- 10 you know, determining issues of financial feasibility of the
- 11 implementation of the strategic plan.
- 12 So is it, are we as a group contemplating that there
- 13 would be a separate Financial Feasibility Technical Advisory
- 14 Coalition or that that function would be added to the existing
- 15 Technical Advisory Coalition?
- MS. MOORE: Not that will it be added.
- 17 If you recall when this committee structure, which
- 18 actually has been in place since last year, was the
- 19 opportunity to kind of divide up and share the workload of
- 20 this master site planning process and strategic planning
- 21 process.
- 22 The Technical Advisory Coalition is very specific to the
- 23 technical elements that will be necessary to a Master Site
- 24 Plan.

- 1 These are specialists in the areas of CEQA and EIR
- 2 documents and things like that.
- 3 Separately, and so that's where it's not financial
- 4 technical experience.
- 5 So that's who that group is.
- 6 These are biologists and geologists and so forth, that
- 7 there are 13 areas of the CEQA that will need to be addressed
- 8 through this process and with specialists in each of those
- 9 areas.
- 10 You all were invited as board members to offer names and
- 11 suggestions into that process.
- Because this is a group of people, again, working on a
- 13 pro bono basis and bringing their expertise to us.
- 14 Then in addition to that, and that's why this liaison
- 15 group, and what that group, the coalition has done so far is
- 16 meet as has previously been reported on.
- 17 They have met here.
- 18 They have been here.
- 19 They've done a site tour of the fairgrounds.
- We are providing them information at this point that they
- 21 are digesting and going through liquefaction and things like
- 22 that come to mind as well.
- Then separately we had the Economic and Feasibility
- 24 Committee, which was going to be in phase two.

- 1 That has now been combined with the Conceptual Committee,
- 2 and that's where the financial aspect sort of more of the
- 3 business opportunities of the fairgrounds.
- 4 That's where we're looking at now would be in phase two.
- 5 In this phase one what we have spent this past year on is
- 6 really that public awareness building.
- 7 And that was the goal.
- 8 The community is going to know about the project upfront.
- 9 We aren't going to wait until once we have the Master
- 10 Site Plan.
- 11 So as we shift into phase two now is when we'll be
- 12 looking to bring, and whether economists, experts in their
- 13 field and so forth.
- 14 The ideas that some people have about opportunity that
- 15 could happen here at the fairgrounds and whatever for that,
- 16 you know, new business as well as assessing and analyzing our
- 17 current business would be done through that committee.
- 18 DIRECTOR GELFAND: Given the fact that we're heading into
- 19 budget season, I would encourage Directors Arabo and Mead to
- 20 come back to the Board with recommendations about how they, as
- 21 a committee and then ultimately the Board, are going to be
- 22 informed about financial feasibility issues and whether they
- 23 are going to recommend to us as a board that we form another
- 24 pro bono committee of experts or whether we hire and have to

- 1 budget for experts to assist us.
- I just don't want that issue not dealt with correctly.
- 3 MS. MOORE: I describe it as, you know, when we talk about
- 4 our map that we're on, this journey, right, to get to the
- 5 Master Site Plan, and we refer it to as the Candy Land game.
- 6 If you recall in Candy Land, there's this area, it's the
- 7 molasses swamp or something like that, off to the side.
- 8 That's the -- because what we've done is we've expanded
- 9 the work even from our initial iteration of this in the public
- 10 arena, the public outreach through the committee work that was
- 11 done previously and saying, hey, this is how we want to expand
- 12 that.
- 13 As we're transitioning now to the purple section, and
- 14 that's kind of this phase that we're talking about is seeing
- 15 that expand out further.
- 16 And so to your point, Director Gelfand, where we will
- 17 start to identify those milestones as well as and expand the
- 18 game board.
- 19 So this board is what is the process we're going to be
- 20 continuing through this.
- 21 When we started that green section, for example, was just
- 22 a few blocks and then we expand.
- DIRECTOR GELFAND: So you're anticipating the purple
- 24 section will expand.

- 1 MS. MOORE: Yes.
- DIRECTOR GELFAND: Perfect.
- 3 Because my concern was that there's nothing in the Candy
- 4 Land board that talks about financial feasibility really being
- 5 thoroughly studied by outside advisors.
- 6 And when it was designed I thought it would be the
- 7 coalition that we currently have.
- 8 That it would be both geotechnical and that kind of thing
- 9 as well as financial.
- 10 So as long as --
- MS. MOORE: Right now we don't, for example, this board
- 12 hasn't had discussion and just ideating around the
- 13 possibilities.
- 14 You know, when we talk about those financial experts,
- 15 part of that is going to be to look at not just what it is we
- 16 currently do but we're talking about a fairgrounds of the
- 17 future.
- 18 So what does new business look like.
- 19 And over the years and during COVID, you know, we had
- 20 various people reaching out to us with ideas for the property
- 21 as well.
- We've heard some, you know, from the community.
- I'm sure you as board members do as well.
- 24 And so having that opportunity to just more ideate to

- 1 then help identify the areas of focus is what is next.
- 2 And really that game board started out as our outreach
- 3 and engagement plan, which gets us to it a Master Site Plan.
- 4 That's why we need to spend time now in this, the way we
- 5 have the green section of outreach.
- 6 DIRECTOR ARABO: I have a question.
- 7 For this committee, this is a carryover.
- 8 We would assume we have work that we'll review of the
- 9 committee that they did.
- 10 Or, is this -- no, the financial economic feasibility.
- 11 There was a committee before, it's not a new committee.
- 12 It was a current committee, correct?
- MS. MOORE: It was a committee but anticipated in phase
- 14 two, so that's why we're transitioning into this from -- so
- 15 the phase one committee was more active.
- 16 Really the environmental stewardship was the intent had
- 17 been for it to be active.
- 18 We were just getting -- Director Mead was on that.
- 19 We were just getting started with that when we had some
- 20 changes on the Board.
- 21 And so it just seemed timely to kind of reset on that
- 22 now.
- Because as we know, we are stewards of this
- 24 environmentally sensitive area.
