

You will need to register every year- ShoWorks does not carry information over from last year.

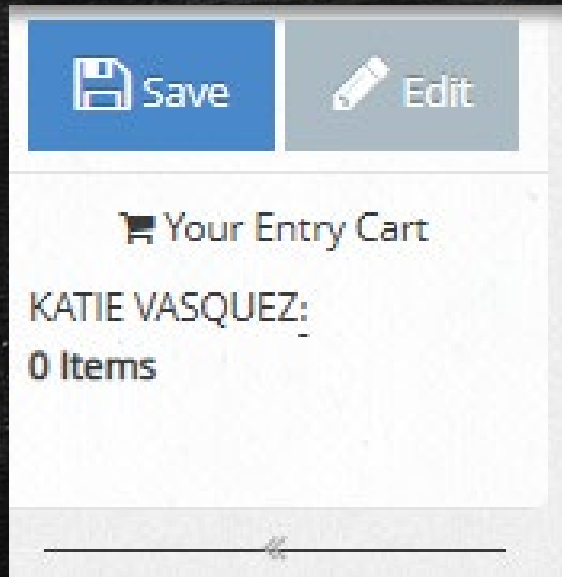

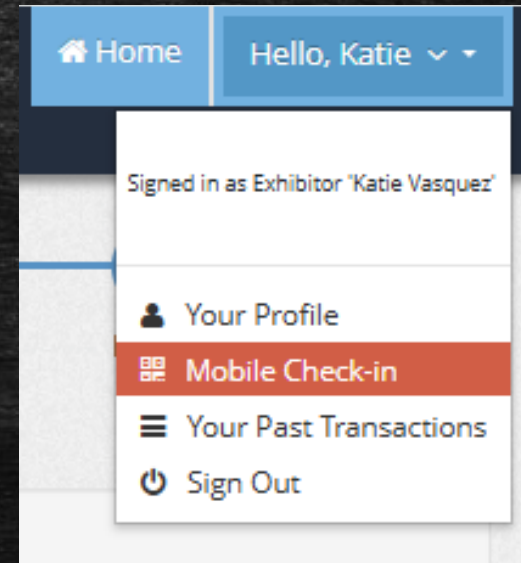
