To be eligible to enter and show at the San Diego County Fair Junior Livestock Show, all market exhibitors must submit for each of their animals: **THIS COMPLETE PROJECT AGREEMENT FORM, A COPY OF THE BILL OF SALE, COPY OF PROP 12 CERTIFICATE (SWINE ONLY), TWO COMPLETE DNA ENVELOPES AND SAMPLES, & A PHOTO OF THE EXHIBITOR WITH THE ANIMAL (Per State Rules).** All items must be completed and submitted together to the San Diego County Fair Entry Office on or before the following deadlines:

MARKET BEEF: delivered in-person to the Entry Office or postmarked by 5:00 PM on Monday, February 23, 2026.

MARKET SWINE, SHEEP, & GOATS: delivered in-person to the Entry Office or postmarked by 5pm on Friday, April 24, 2026.

All Market Tags will be sent to Mailing Address found below or scheduled for pick-up in SDCF Entry Office *after* DNA is submitted.
